- An undertaking shall be taken from every beneficiary under this scheme to the effect that excess payment made on account of incorrect fixation of pay in the revised pay level or grant of inappropriate Pay Level and Pay Cells or any other excess payment made shall be adjusted against the future payments due or otherwise to the beneficiary (copy enclosed).
- All the Dy. Registrars/ Dy. Comptrollers/ Assistant Registrars/ A&AOs/ Superintendents are authorized to fix the pay of the teachers/equivalents and other administrative staff as per Rule 5.2(8) of Chapter -5 of Account Code Volume-1, LUVAS working under their Offices/Departments/Colleges/Directorates irrespective of the scheme in which the teachers/equivalents and other administrative staff are working. In case of Colleges/Directorates/Controlling Officers, where there is no post/incumbent of Dy. Registrar/ Dy. Comptroller/ Assistant Registrar/ A&AO/ Superintendent, the pay fixation of the teachers/equivalents and other administrative staff will be approved by the O/o Comptroller,

LUVAS, Hisar. However, all the Officers/ Officials concerned shall keep in view the general instructions and clarifications issued in this regard from time to time.
