In view of the rapid surge in COVID-19 cases in the State and in pursuance of the instructions issued by Office of Chief Secretary, Government of Haryana, Chandigarh vide No. 62/69/2021-6GS1 dated 4.01.2022, it has been decided with the approval of competent authority that all the Offices/Departments/Sections/ Lab. (including outstations) will follow the following guidelines/instructions till further orders:

1. All the Group A & B (Class-I & II) Officers including faculty members/teaching staff will attend the office on regular basis.
2. Group C & D (Class III & IV) employees will attend the offices with atleast 50% strength on roster basis and remaining 50% will work from home. The Roster for duty will be prepared by the respective Controlling Officers/Deans/Directors/ HODs/ In-charges/ Lab. Incharge (including outstations).
3. The Person with disabilities and pregnant women employees will be exempted from attending office and they will work from home.
4. The officials residing in Containment Zones will be exempted from coming to office till the Containment Zones are de-notified.
5. All the officials who do not attend office on a particular day must be available on Telephone at all times from their residence and work from home. However, the concerned Deans/Directors/HoDs/Officers (including outstations) will call any official for work on any day, if required.
6. Meeting as far as possible, will be conducted through video-conferencing.
7. The concerned Deans/Directors/HODs/Officers/In-charges/Lab. Incharge (including outstations) will ensure that all the officials who attend the office will strictly follow Covid appropriate behavior including wearing of mask, physical distancing, use of sanitizer and frequent hand washing with soap and water.
8. Entry of the Outsiders, visitors in the Offices/Departments of the University will be curbed unless absolutely necessary.
