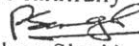

At the outset, the Chairman welcomed the Chief Secretary, Additional Chief Secretary, Government of Haryana, Finance & Planning Department, Principal Secretary, Government of Haryana, Animal Husbandry & Dairying Department, and all the members of Board of Management.

Thereafter, salient developments in the university since the last meeting of the Board held on 11.08.2015 were briefed to the Board. The Chairman informed the Board that during this period a mega function of holding 1<sup>st</sup> Convocation of the university was held on January, 28, 2016. Sh. Radha Mohan Singh, Hon'ble Union Minister of Agriculture and Farmers Welfare, Govt. of India was the Chief Guest. 182 UG and 134 PG students were awarded degrees. Thirty Eight Clerks were appointed. Veterinary and Livestock Development Diploma seats have been increased from 60 to 80 from the academic year 2016-17. Girls have also been allowed for admission in the diploma course. Qualification has been modified from 10+2 (any stream) to 10+2 with Biology. SDS College, Tohana has been granted affiliation from the year 2015-16 for VLD Diploma Programme. VCI team inspected the College on 09-11 February, 2016 to inspect manpower and general facilities as per VCI Rules and Regulations. B.V.Sc & A.H. seats for Haryana Residents have been increased from 59 to 67.

LALA LAJPAT RAI UNIVERSITY OF VETERINARY & ANIMAL SCIENCES HISAR - 125 004

Hon'ble Chief Minister of Haryana laid down the foundation stone for establishment of Referral Veterinary Diagnostic & Extension Centre (RVDEC) at Rewasa (Mahendergarh), on 9<sup>th</sup> April, 2016. The matter regarding establishment of Veterinary Diagnostic & Extension Centre (RVDEC) at Ambala is in progress and MoUs were signed with DIHAR, DRDO and Pirbright Institute, UK.

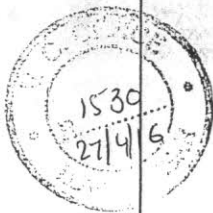
