At the outset, the Chairman welcomed the Chief Secretary, Govt. Haryana, Smt. Rajni Sekhri Sibal, IAS, Additional Chief Secretary, Government Haryana, Animal Husbandry & Dairying Department, Smt. Amneet P. Kumar, IAS, Special Secretary, Finance Department, Govt. of Haryana, and all the members of Board of Management.

The Chairman apprised the Board of the developments which took place in the university after the last meeting of the Board. It was informed that a high level team of National Agricultural Education Accreditation Board (NAEAB) visited LUVAS for two days in October, 2016 and inspected the relevant documents, curriculum, strength/weakness of the university. Accordingly, the university has been accreditated for the first time by the Board. It was also informed that the total milk production in the university has increased from 3,28,336 Lts. to 5,46,372 Lts. from

2012-13 to 2015-16, respectively. New Generation Sequencing facility has been established under Indo-UK project in LUVAS leading to rapid multitude molecular genomic and reverse vaccinology interventions. LUVAS developed "Fluorescence Polarization Assay" for rapid and multi-fold sero monitoring of Brucellosis which could be an asset for Brucellosis Control Programme launched by Govt. of India. A piece of land measuring 1125 acres has been allotted to LUVAS at Ram Dhan Singh Seed Farm which is 12 kms away from the Bus Stand. The Hon'ble Chief Minister, Haryana has given his consent for laying foundation stone of the New Campus on 27th November, 2016. An entrance test was conducted for admission to M.V.Sc. and Ph.D. programme. For the first time girl students have been admitted in VLDD course. A total of 11 Messengers, 17 Animal Attendants, one Dairy Supervisor, one Assistant Manager, one Dairy Manufacturing Assistant and one X-ray Room Helper have been recruited. Two Associate Professors/equivalents were promoted as Professors/equivalents, one Assistant Professor/equivalent (Stage-I) was promoted as Associate Professor/equivalent (Stage-III), one Assistant Professor (Stage-II) was promoted as Assistant Professor (Stage-III) and five Assistant Professor were placed from Stage-I to Stage-II. Eight Clerks have been promoted on the post of Assistant. One Senior Scale Stenographer has been promoted as Personal Assistant. There is no pending case for promotion of teaching and non-teaching employees. One Scientist Dr. Sandeep Kumar, Department of VPB was placed under suspension on 22.8.2016 for threatening HoD, VPHE and misbehavior with SPS to Vice-Chancellor.
