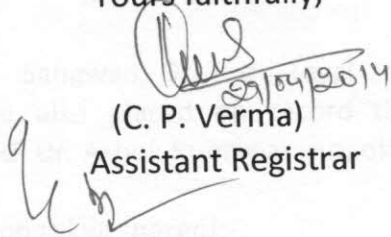

Agenda Item No. 22A-8

Approval of revised synopsis of Ms. Anita Dalal, M.V.Sc. student, Admission No. 2012V29M.

The Council viewed the whole situation very seriously particularly lack of proper planning and guidance on the part of Major Advisor and decided as under:

1. Major Advisor be counselled for not proper planning and guidance to the student.
2. Major Advisor of the student be changed.
3. Council allowed change of research topic with the condition that there shall be no consideration for relaxation in rules regarding time of submission of thesis.

Agenda Item No. 22A-9

Gold Medal/Award rules – Dr. R. N. Srivastava, Gold Medal.

Approved as proposed by the Board of Studies with the exclusion of Head of Department, Biotechnology and Molecular Biology from the scrutinizing committee.

Agenda Item No. 22A-10

Registration of UG & PG Students.

Approved as proposed by the Board of Studies except that the proposed late fee be revised to **Rs.200/-** per day.

Agenda Item No. 22A-11

Amendment in Lala Lajpat Rai University of Veterinary And Animal Sciences, Hisar Act of 2010.

The issue was discussed in detail and it was decided to get the legal opinion on the issue in the first instance.

Agenda Item No. 22A-12 Prospectus for the Academic Year 2014-15.

The draft prospectus 2014-15 was approved with the following amendments/additions:

- A. Page- 1 Sr. No. 5** The following is to be substituted:
Counselling: First counselling will commence w.e.f. 25.07.2014. The details of counselling schedule and cut off date (2nd counselling) shall be displayed on the website www.luvas.edu.in latest by 21.07.2014. Same changes are to be made in point (b) of Annexure-I at page-38.
- B. Page- 3 Sr. No. 7** The sentence '**No representation regarding fluctuations in dollar rate will be entertained**' be added.
Page-3 Sr. No. 12 May be read as:
 'University has imposed a ban on the use of motorized vehicles in the hostels. **The student, who occupies accommodation in the hostel, has to submit an affidavit as per Annexure-XV.**
- Page-3 Sr. No. 13** To be added: '**The candidates will not be allowed to carry question booklets alongwith them after the Entrance Test.**'
- C. Page-9 rule 1.4** The sentence '**The certificate of the concerned Board/University should be submitted within a month of registration.**' is to be added.
- D. Page- 11 rule 3.4 (iv)** The first line to be substituted with '**The candidates must bring with them two blue or black ball pens**'.
- E. Page- 12 rule 3.7 i) b)** The first sentence '**Writing his /her name or putting any identification mark on the outer cover of question booklet or anywhere on the OMR sheet**' **to be deleted.**
Page-12 Rule 3.7 ii) The words '**or found being impersonated by another candidate**' be added in the first line after the words another candidate.
Page-12 Rule 3.7 iii) To be substituted as: '**If use of unfair means is detected at the time of evaluation of the OMR sheets/counselling or thereafter or any complaint (anonymous/pseudo anonymous) is received after admission and it is proved to be correct after an enquiry, the candidate shall be disqualified and admission cancelled as the case may be and debarred from seeking admission in this University.**
