Thereafter the agenda items were discussed and the following recommendations were made :

Item No. 1 RIC-1 : Deadline for submission of synopsis by M.V.Sc. and Ph.D. students.

Recommended and RIC proposed minor changes in Rule 14.1 of University Calendar Volume-II, Chapter-III as under :-

14.1 Preparation of the Draft thesis / Synopsis

- (a) *A student preparing for Master's **OR** Ph. D. degree shall submit the subject of proposed thesis and its synopsis (Form PG-3) as per Appendix IX of this Chapter) to the Dean, PGS (through **Major** Advisor / HOD). Major Advisor will ensure that it should be **submitted to the Dean, PGS** before the registration of 3rd semester of **his / her** admission under all circumstances failing which it will not be accepted after the stipulated period and admission shall stand cancelled. Comprehensive written examination will not be held **until** the synopsis is approved by the Dean, PGS.*

It may be made effective from the academic session 2017-18.

Item No. 1RIC-2: Enhancement of stipend / merit stipend being offered to M.V.Sc. & Ph.D. students of LUVAS.

Recommended as proposed with the following changes:-

2) **Stipend is recommended to be granted to all the admitted students whether domicile of Haryana or not.** Merit stipend will be granted only to students having domicile of Haryana.
