Thereafter, the agenda items were placed before the RIC and the following decisions were taken thereof :

Agenda Item No.10 RIC-1: Confirmation of the proceedings of 9th meeting of RIC held on 24.11.2017.

Agenda Item No.10RIC-2:Action taken report on the proceedings of 9th meeting of Resident Instruction Committee (RIC) held on 24.11.2017 PM in the Committee Room of Dean, PGS, LUVAS, Hisar.

Agenda Item No. 10 RIC-3: Waiving of fee for 'I' Grade examination of P G student who has been sent to attend Workshop / symposium / Conference to represent the University under rule 11.1 (v) of chapter-III University Calendar

Recommended as proposed subject to the condition that this will be admissible only if the student is first and presenting author of the paper to be presented. The matter may be placed before the Academic Council for consideration please.

Item No. 10RIC-4 : Reconsideration of criteria for award of Merit Gold Medal for Doctorate programme.

The request of Dr. Deepika, Assistant Professor on the issue was discussed at length and it was felt that Merit Gold Medal for Doctorates as prescribed in University Calendar Vol-II Chapter VII Rule 4 Part-2 (i) are very much clear and there is no need for any change in these rules. Dean PGS may inform the applicant accordingly. The RIC has recommended to close the issue.

**Item No. 10RIC-5 : Discontinuation of degrees in M.V.Sc. and Ph.D.
in Veterinary Immunology**

The recommendation of the committee constituted by the Academic Council was placed before the members which are reproduced here as

“The committee discussed the matter keeping in view the information obtained from the various Institute/ Universities and department. The committee is of the opinion that students seeking admission in M.V.Sc. and Ph.D. Immunology have no academic scope and avenues for placement in the teaching institutes and Universities in India. Therefore, committee resolved unanimously that in the interest of the students there is no need for continuation of M.V.Sc. & Ph.D. in Veterinary Microbiology and Veterinary Immunology separately. Henceforth. The degrees in M.V.Sc. and Ph.D. in Veterinary Microbiology only may be awarded by LUVAS”.

The RIC considered the matter at length and agreed to the recommendations of the committee that there is no need for continuation of M.V.Sc. and Ph.D. in Veterinary Microbiology and Veterinary Immunology separately from the Academic Year 2018-19 and also agreed that henceforth the degrees in M.V.Sc. and Ph.D. in Veterinary Microbiology only may be awarded by LUVAS. It was recommended to place the matter before the Academic Council in the ensuing meeting for consideration and decision.

**Supplementary Agenda : Introducing a new course titled “ Bio – Stat - 611
Item No. 10RIC-6 Statistical Methods for Biological Workers (1+1)**

RIC considered the proposal submitted by HoD AGB and has recommended for the introduction of a new course as supportive subject from the Academic Year 2018-19 with credit hours of 1+1 for Master's programme in all disciplines. This course will be compulsory for all the students of M.V.Sc. However, Ph.D. students may be exempted from the course, if already studied during Master's degree. Recommended as proposed. The matter may be placed before the Academic Council for consideration and decision please.
