The decision taken on the agenda item No. 13RIC-3 and 13RIC- 4 by the Academic Council in its 42<sup>nd</sup> meeting held on 04.05.2018, received vide Registrar's office Memo. No. Regr. / A-1 /2018 / 1541-56+E dated 25.05.2018 vide which Draft Prospectus item No. 42A-3 and Academic Calendar of M.V.Sc. and Ph.D. Programmes for the Academic Year 2018-19 item No. 42A-4 were brought to the notice of members of RIC.

**Agenda Item No. 14 RIC-3: Reg. Postponement of Counseling Schedule for fresh  
admission in M.V.Sc. and Ph.D. Programmes in Ist  
Semester of Academic Year 2018-19**

Members of RIC were informed that 17 seats for M.V.Sc. and 18 seats for Ph.D. are to be filled in the LUVAS on the recommendations of ICAR in the Ist Semester of Academic Year 2018-19. These seats were to be filled in 3 rounds, 1<sup>st</sup> round from 6<sup>th</sup> July to 10<sup>th</sup> July, 2<sup>nd</sup> round from 12<sup>th</sup> July to 16<sup>th</sup> July, 2018 and in 3<sup>rd</sup> round from 16<sup>th</sup> July to 22<sup>nd</sup> July, 2018. The ICAR has not recommended any name for admission in LUVAS so far as ICAR has rescheduled its entrance test on 18<sup>th</sup> and 19<sup>th</sup> August, 2018. Therefore, the RIC has recommended to postpone the scheduled counselling programme earlier circulated/ as per Prospectus for fresh admission in MVSc and Ph.D. for the Ist semester in LUVAS. The fresh dates for counseling will be communicated in due course of time. The case

may be submitted for approval of worthy Vice Chancellor in anticipation of approval of the Academic Council.

**Agenda Item No. 14 RIC-4: Reg. Postponement of Academic Calendar  
for in M.V.Sc. and Ph.D. Programmes for the  
Academic Year 2018-19**
