At the outset, the Chairman, welcomed all the Hon'ble members in the 20th meeting of the Resident Instruction Committee (RIC) and wished that the contribution of members in this meeting will be constructive and useful. Dr. Gulshan Narang, HoD VPP was away from Hqrs in his place Dr. Vinod Kumar, HoD VPTX—cum- Secretary BOS has worked as Member Secretary, RIC.

Thereafter, the agenda items and supplementary agenda items were placed before the RIC and the following decisions were taken thereof:

Agenda Item No.20RIC-1: Confirmation of the proceedings of 19th meeting of RIC held on 07.03.2019

Since no comments were received, the proceedings of last 19th RIC meeting held on 07.03.2019, were confirmed by the RIC.

Agenda Item No.20RIC-2: Action taken report on the proceedings of 19th meeting of Resident Instruction Committee (RIC) held on 07.03.2019 in the office of Dean PGS, LUVAS, Hisar.

The Member Secretary, RIC presented the action taken report which was approved by the house except **Agenda item No. 19RIC-7** to the extent that the amendment in University Rule 6 of Chapter of University Calendar Volume-II made vide Amendment No. 6/2019 issued by the Registrar, LUVAS vide Endst. No. Reg.902-936 dated 22.03.2019 in pursuance of the decision taken by the Academic Council vide Agenda item No. 46A-9 in its 46th meeting may be applicable from 1st

semester of Academic Year 2018-19 because Dr. Priyanka, Admn. No. 2017V29M has rejoined her study in the same semester 1st semester of Academic Year 2018-19 after dropping to join as Veterinary Surgeon.

RIC has recommended to place the matter before the Academic Council for modification of applicability of this Rule from 1st semester of Academic Year 2018-19 instead of 2nd semester of Academic Year 2018-19.

Agenda item No. 20 RIC-3: Drafting of Prospectus for PG(M.V.Sc. and Ph.D. Programmes for the Academic Year 2019-20.

The RIC accepted the demand of HoD's regarding the number of tentative seats to be proposed for the Academic Year 2019-20 in the meeting of Board of Studies in its meeting held on 4.4.2019, and proposed a revised draft for PG(M.V.Sc. and Ph.D.) Programme for the Academic Year 2019-20. The Resident Instruction Committee (RIC), has taken into consideration the proceedings of the meeting of the Prospectus Committee held under the chairmanship of Dean PGS LUVAS on 03.04.2019. The RIC also kept in mind the instructions issued from time to time by various authorities, the instructions issued by Government of Haryana regarding reservation in admissions, especially the instructions issued by Government of Haryana vide No. 22/12/2019-1GS-III dated 25th February, 2019 reservation for Economically Weaker Sections in admissions as mentioned in the proceedings of meeting of Prospectus Committee held on 3.4.2019. The present faculty strength viz a viz number of seats to be filled in the department keeping in view the teaching load of each faculty member and the period of retirement of faculty(S) was also taken into consideration. The increase in number of seats in M.V.Sc. in LPM from 1 to 2, in VGO from 2 to 3 and in VPTX from 1 to 3 in the Academic Year 2019-20, date of availability of Admission Forms on the university website, last date of submission to submit off line admission form without late fee and with late fee, date of entrance test for M.V.Sc., date of declaration of result of entrance test for admission in M.V.Sc. Admission in Ph.D. on the basis of Academic merit and institutional weightage instead of entrance test and other amendments as proposed by the Prospectus Committee have been made in the draft prospectus.

The RIC has recommended the draft prospectus 2019-20 (M.V.Sc. and Ph.D. Programmes) for placing before the Academic Council for kind consideration and approval please.

Agenda item No. 20RIC-4 Distribution of marks for mid-term, end term and practical for 1+3 credit hours and other practical courses of 0+1, 0+2 and 0+3 credit hours examinations

The RIC has considered the matter and proceedings of the Committee constituted by the Academic Council in pursuance of its 46th meeting held on

18.03.2019 to amend the university Rule 7.7, Chapter-III of University Calendar Volume-II and recommended the following additions/amendment in Rule 7.7 of Chapter –III University Calendar Volume-II as below:
