Agenda item No. 26RIC-3: Change of name of course and code from Basic of Biostatistics to Introduction to Biostatistics or Elements of Biostatistics etc. and Course code from BIOSTAT-611 to BST-611 or BSTAT-611 etc. or Biological Sciences or "BST 611 Statistics of Biological Sciences,".

The RIC has considered the agenda and recommended to change the name as "Statistics of Biological Sciences" instead of Basic of Biostatistics. The code was also proposed to be changed from BIOSTAT-611 to BST-611. Rule 18.2(b) (ii) and 18.3(b) (ii) be modified in Chapter-III University Calendar Volume-II accordingly and place the matter before the Academic Council for consideration and approval please.

### Agenda point No. 26RIC-4: Regarding starting of Post Graduate programme in Dairy Science and modification in Chapter-III, University Calendar Volume-II.

- (a) The agenda was placed before the RIC. The RIC has recommended the number of seats as proposed for starting of Post Graduate Programme in different disciplines of College of Dairy Science and Technology in LUVAS from the Academic Year 2020-21. The agenda (annexure page 8) may be placed before the Academic Council for according approval from the Academic Year 2020-21.
- (b) The RIC has further recommended to place the Course Structure and eligibility conditions for Post Graduate Programme in different disciplines of College of Dairy Sciences and Technology(annexure pages 9 to 15) before the Academic Council for kind consideration and approval please.
- (c) The RIC has gone through the proposed modifications (annexure pages 17 to 31) and recommended to place the agenda before the Academic Council (except Non-Credit Compulsory Courses) for kind consideration and for amendment in Chapter-III University Calendar Volume-II please.

## Agenda item No. 26RIC-5: Amendment in Rule 23(a) Chapter-III, University Calendar Volume- II – Refund of Tuition Fee (Security) & Refund Policy in Prospectus.

The agenda was placed before the RIC for consideration. The RIC has not approved the proposed amendment and dropped the same.

### Agenda item No. 26RIC-6: Adding of grading pattern in Rule 10.1 in Chapter-III University Calendar Volume-II on point scale.

The RIC has considered the agenda in detail and decided to recommend that if Total marks (Mid-term + Final term+ Practical) comes in decimal than the decimal marks of 0.5 or above will be counted on the higher side e.g. if total marks scored in a course of 1+1 credit hours are 76.5 then marks will be counted on the higher side i.e. 77 and Grade point on 10.00 scale will be 7.7". The RIC has recommended to modify Rule 10.1 of Chapter-III University Calendar Volume-II as under:

(2) Credit Point in a subject shall be GP multiplied by the credit hours. The credit points earned will be zero if the GP in a subject is less than 5.00. The credit points earned will be zero if the GP in a subject is less than 6.5 except PGS-501 (non credit course) minimum passing marks will be 60% (6.0 Grade Point) instead of 65% (6.5 Grade point) till the course is offered by LUVAS.

This will be applicable for the students in admitted in the  $1^{\rm st}$  semester of Academic Year 2019-20 and onwards".

RIC has recommended to place the agenda before the Academic Council for consideration and according approval for adding the above recommendation in Rule 10.1(1) and 10.1(2) of Chapter-III University Calendar Volume-II.
