Agenda item No. 28RIC-3: Conduct of final examinations for 2nd semester of academic year 2019-20.

The mid –term and final term examinations of 2nd semester of Academic Year 2019-20 of M.V.Sc. and Ph.D. students which were scheduled to be held from 20.03.2020 to 31.3.2020 and 11.6.2020 to 22.6.2020, respectively, could not be held due to COVID-19 lock-down. Due to present situation of COVID-19, it is proposed that the examination process for the current semester will be held on- line and may be conducted from 1st to 12th October, 2020 as per the enclosed date sheet (Annexure A). The results may be submitted to the Dean PGS LUVAS Hisar by 16th October, 2020 and the mode of on-line examination of M.V.Sc. and Ph.D. students is proposed as under:-

- a. The mode for conducting M.V.Sc. and Ph.D. examinations will be on-line. The mid-term theory examination will consist of two components: Assignment and Viva-voce with a weightage of 50% each. The final-term theory examination will consist of two components: Assignment and Viva-voce with a weightage of 50% each. For the courses having theory as well as practical component, the final practical examination will consist of two components: Power-point Presentation and Viva-voce.
- b. For courses having practical component only, the mid-term practical examination will consist of two components: Assignment and Viva-voce. The final-term practical examination will consist of two components: Power-point presentation and Viva-voce. The topics allotted to individual students by the concerned teacher for assignment and power-point presentation should be different. The last date for on-line submission of assignments by the students is 12th October, 2020.
- c. Date sheet for conducting online examination (power point presentation and viva-voce) will be issued by the Dean PGS to all HoD's and will be uploaded on University website for the information of all concerned students/ teachers. However, all HoD's and teachers will inform students telephonically as well as through e- mail. The examinations will be conducted from 1st to 12th October, 2020 as per issued date sheet and teachers will submit final result by 16th October 2020 on the prescribed proforma.
- d. Credit seminar may be delivered by the student on-line/off-line as per convenience of the teachers with consultation of HoD. The student may be informed well in advance by the concerned teacher.
- e. The research synopsis of students admitted in the academic year 2019-20 needs to be submitted and got approved before registration of 4th semester.

Note: The teacher, if feels that physical presence of student(s) is essential, he can call the student(s) and should maintain the social distancing during examination. It is made clear that no hostel facility will be provided to student(s).
