condition, however, shall be imposed on the student who has left the studies for joining services to come back and resume his/her Ph.D. / M.V.Sc. studies and it will be for the student to decide as to at what stage he/she wants to come back and resume studies. However, he/she will not be allowed to exceed maximum duration allowed to complete the degree and shall not be given any exemption -from the rules prescribed for getting extension. Dropping the semester with any reason whatsoever, with the permission of the competent authority or including dropping otherwise with the permission of the competent authority to join services, no concession shall be given while counting the normal duration within which a student is supposed to complete the degree.

condition, however, shall be imposed on the student who has left the studies for joining services to come back and resume his/her Ph.D. / M.V.Sc. studies. **However, the student shall** have to re-join his/her studies within five years from the date of discontinuation. He/she will not be allowed to exceed maximum duration allowed to complete the degree and shall not be given any exemption from the rules prescribed for getting extension. Dropping the semester with any reason whatsoever, with the permission of the competent authority or otherwise including dropping with permission of the competent authority to join services, no concession shall be given while counting the normal duration within which a student is supposed to complete the degree.

The RIC has considered the above agenda item and recommended to place the proposal of amendment in Rule 19.2 (C) of chapter-III of University Calendar Volume-II, LUVAS, before the Academic Council for kind consideration and approval, please.

Agenda Item No. 29RIC-4: Creation of one supernumerary sports quota seat in each constituent college of LUVAS for admission in Master's Progaramme

The RIC has considered the above agenda item at length and recommended for creation of one supernumerary sports quota seat in each constituent college of LUVAS for admission in Master's Programme on basis of following criteria:

- 1. First three positions in recognized Inter-national competitions/Championships recognized by concerned game federation.
- 2. Participation in the recognized Inter-national competitions as above.
- 3. First three positions in National Championship/All India Inter-State Championship organized under the auspices of National Sports Federation/Association.
- 4. Participation in National Championship/All India Inter-State Championship organized under the auspices of National Sports Federation/Association.
- 5. First three positions in All India Inter-University Championships organized under the auspices of AIU.
- 6. First three positions in the Zonal Inter-University Championship organised under the auspices of AIU or first three positions in Zonal Inter-State Championship organised under the auspices of National Sports Federation/Association.
- 7. First three positions in All India InterVeterinary/Agricultural University Sports Meet under the auspices of ICAR.
- 8. If the sports achievements of two candidates are at par as per above mentioned criteria then the admission on supernumerary sports quota seat will be done as per University admission Rules on basis of academic merit.

- 9. Only the performance of preceding five and four years will be considered for admission in M.V.Sc. and M.Tech. Programme, respectively. The cut-off date for counting preceding four/five years will be the last date for submission of application form for admission.
- 10. The other minimum requirements for admission to Master's degree will be same as for others except the condition of appearing in the entrance test.

The RIC has further recommended to place the matter before the Academic Council for kind consideration and approval, please.

Agenda Item No. 29 RIC-5 Extension of 2nd semester of Academic Year 2019-20 for PG students who are in their last semester of degree programme.

The RIC has considered the above agenda item and agreed that the current semester (2nd semester of Academic Year 2019-20) may be extended till 15th January, 2021. This will be applicable only for those PG students (M.V.Sc. & Ph.D.) who are in last semester of their degree programme. The RIC has further recommended to place the proposal to worthy Vice-Chancellor for kind consideration and approval in anticipation of approval by Academic Council as the time is very short.
