Thereafter, the following items were discussed and the following decision taken thereof:

**Agenda item No.32RIC-1: Confirmation of the proceedings of 31th meeting of the RIC held on 17.12.2020.**

**Agenda item No. 32 RIC-2: Action taken report on the proceedings of 31th meeting of RIC held on 17.12.2020.**

**Agenda Item No. 32RIC-3: Regarding withdrawal of the paragraph in note of serial no. 7 on page no. 24 in the PG prospectus.**

The draft prospectus for the academic year 2020-21 was approved by competent authority in 53<sup>rd</sup> meeting of academic council held on 26.11.2020. Inadvertently, in the finalized prospectus in the **Notes of serial No. 7 on page number 24**, there existed a paragraph which read as **“The children of persons of Backward Classes claiming reservation under backward classes shall have to submit at the time of Counselling BC Certificate issued by the competent authority on or after 01.10.2020 as per Annexure-V having gross annual income of up to three lakh**

rupees shall first of all get the benefit of reservation. The left out quota shall go to that class of Backward Classes of citizens who earn more than three lakh rupees but up to six lakh rupees per annum. The sections of the Backward Classes earning above six lakh rupees per annum shall be considered as creamy layer.”

In order to ensure compliance with the decision taken by honorable High Court of Punjab and Haryana at Chandigarh while deciding C.W.P. No.15731 of 2018 dated 7.8.2018, the above paragraph in the Notes of serial No. 7 on page number 24 of the PG prospectus was withdrawn and replaced as under:

‘The children of persons of **Backward Classes** claiming reservation under backward classes shall have to submit at the time of counseling **BC-A/BC-B** certificate issued by the competent authority on or after **01.04.2020** as per Annexure-V.

Keeping in view the shortage of time and urgency of matter the case was submitted to worthy Vice-Chancellor subject to ratification by RIC and thereafter by Academic Council. The worthy Vice-Chancellor was kind enough to approve the same.

**The above agenda item has been ratified by the RIC and thereafter RIC recommended that the agenda item may be placed before the Academic Council for its ratification in the ensuing meeting.**
