Thereafter, the following agenda items were discussed and the following decision was taken thereof:

Agenda item No.33RIC-1: Confirmation of the proceedings of 32nd meeting of the RIC held on 03.02.2021.

Agenda item No. 33 RIC-2: Action taken report on the proceedings of 32nd meeting of RIC held on 03.02.2021.

Agenda Item No.33RIC-3: Conversion of vacant seats of ICAR quota for admission in M.V.Sc. Programme to State quota seats.

The first counseling for admission to M.V.Sc. programme for filling up seventeen ICAR quota seats in various disciplines for 2nd semester of Academic Year 2020-21 was conducted by

the office of Dean, PGS on 17.02.2021. During the 1st counseling, twelve (12) ICAR quota seats were filled up from amongst the candidates recommended by the ICAR but five ICAR quota seats remained vacant in disciplines of ABT, VAN, VBC, VGO and VMD due to non availability of candidates from ICAR.

The RIC considered the requests of candidates seeking admission in M.V.Sc. Programme and agreed to convert these vacant ICAR quota seats to State quota seats.

The RIC has considered the above agenda item and recommended to place the proposal to worthy Vice-Chancellor for kind consideration and approval subject to the ratification by the Academic Council in its ensuing meeting.

Agenda Item No. 33 RIC-4: Permission for special counseling and registration to fill these seats.

The 1st counseling for admission in M.V.Sc. programme on ICAR as well as State quota seats was held on 17th February, 2021 and the registration was held on 18th & 19th February, 2021. Thereafter, the 2nd counseling and registration was held on 20th February, 2021 to fill up the vacant State quota seats.

As per agenda Item No. 33RIC-3 the RIC considered the requests of candidates seeking admission in M.V.Sc. Programme and agreed to convert five ICAR quota seats which remained vacant in disciplines of ABT, VAN, VBC, VGO and VMD to State quota seats. It was also agreed that the special counseling and registration may be conducted on 3th March, 2021 and 4th March, 2021 respectively to fill up these converted seats.

The RIC has considered the above agenda item and recommended to place the proposal to worthy Vice-Chancellor for kind consideration and approval subject to the ratification by the Academic Council in its ensuing meeting.
