Agenda item No.35RIC-1: Confirmation of the proceedings of 34th meeting of the RIC held on 26.03.2021.

Agenda item No. 35 RIC-2: Action taken report on the proceedings of 34th meeting of RIC held on 26.03.2021.

Agenda Item No. 35 RIC-3: Conduct of mid-term examinations for M.V.Sc., M.Tech. and Ph.D. Programmes for 2nd semester of academic year 2020-21.

Last year, due to COVID-19 pandemic the mid-term and final term examinations for M.V.Sc., and Ph.D. programmes for 2nd semester of the academic year 2019-20 were held online with the approval of competent authority. This year, the mid-term examinations for M.V.Sc., M.Tech. and Ph.D. programmes for 2nd semester of the

academic year 2020-21 are scheduled to be held from 06.05.2021 to 15.05.2021. However, due to present situation of COVID-19, and with the approval of the competent authority vide Green Sheet/DP/LUVAS/183/14081/2021-2022, Dated 20/04/2021, the offline classes of the PG students have been suspended with immediate effect till further orders. All PG students have been directed to vacate the hostels with immediate effect and no student is allowed to visit the department during this period even for research work. The classes are being conducted in online mode in order to protect the students and employees of the University from COVID-19 pandemic.

Therefore, it is proposed that the mid-term examinations for M.V.Sc., M.Tech. and Ph.D. programmes for 2nd semester of the academic year 2020-21 may be held on-line and may be conducted from 06.05.2021 to 15.05.2021, as per the approved academic calendar for 2nd semester of the academic year 2020-21. The results may be submitted to the Dean PGS LUVAS Hisar by 20th May, 2021 and the mode of on-line examination of M.V.Sc., M.Tech. and Ph.D. students as adopted last year is proposed as under:-

- a. The mode for conducting M.V.Sc., M.Tech. and Ph.D. examinations may be on-line and the examination process may consist of two components: Assignment and Viva-voce.
- b. The mid-term theory examination may consist of two components: Assignment and Viva-voce with a weightage of 50% each.
- c. For courses having practical component only, the mid-term practical examination may consist of two components: Assignment and Viva-voce with a weightage of 50% each.
- d. The last date for on-line submission of assignments by the students is 16th May 2021.
- e. Date-sheet for conducting online mid-term examination (viva-voce) may be issued by the Dean PGS to all HoD's and may be uploaded on the University website for the information of all concerned students/ teachers. However, all HoD's and teachers may inform student telephonically as well as through e- mail. The examinations may be conducted from 06.05.2021 to 15.05.2021 as per issued date-sheet according to approved academic calendar and teachers will submit final result by 20th May 2021 on the prescribed proforma.
- f. Thesis seminar, synopsis seminar, credit seminar may be delivered on-line by the student with consultation of major advisor and HoD. Thesis viva voce and comprehensive viva voce may also be conducted online with prior permission of Dean, PGS. The student may be informed well in advance by the concerned major advisor/HoD.

Note: If the teacher feels that physical presence of student(s) is essential, he can call the student(s) and should maintain the social distancing during examination. It is made clear that no hostel facility will be provided to student(s).

Keeping in view the urgency of the situation due to COVID-19 pandemic, the case may be submitted to Worthy Vice-chancellor for kind consideration and approval subject to ratification by Academic council in its ensuing meetings, please.
