## PROCEEDINGS OF THE 39<sup>TH</sup> MEETING OF RESIDENT INSTRUCTION COMMITTEE (RIC) HELD ON 14.09.2021 AT 12.15 P.M. IN THE OFFICE OF DEAN, PGS, LUVAS, HISAR.

At the outset, the Chairman, welcomed all the Hon'ble members of RIC and special invitees in the 39<sup>th</sup> meeting of Resident Instruction Committee and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and the following decision was taken thereof:

Agenda item No.39RIC-1: Confirmation of the proceedings of 38<sup>th</sup> meeting of the RIC held on 25.08.2021. Confirmed.

Agenda item No.39RIC-2: Action taken report on the proceedings of 38<sup>th</sup> meeting of RIC held on 25.08.2021. Noted and approved.

Agenda Item No.39RIC-3: Regarding permission to PG students for submission of thesis.

As per rule 14.6 (b) of Chapter III of University Calendar Volume II, the PG students submit their thesis in the last semester of residential requirement for PG Programmes after delivering thesis seminar, which is reproduced as under:

## Rule 14.6 (b)

"M.V.Sc and Ph.D. students can submit the thesis only in the last semester of residential requirement. After delivering thesis seminar, M.V.Sc. and Ph.D. students should submit their thesis within three and six months respectively. This period can be extended by the Dean, PGS for three months in both the cases. There should be a minimum gap of 15 days in between thesis seminar and thesis submission".

However, this office has received requests from several M.V.Sc. students of LUVAS, in which they have stated that they have recently appeared for ARS Net 2021

examination and the pre-requisite condition for ARS Net 2021 is completion of degree by 19<sup>th</sup> September, 2021. Afterwards, they requested to allow them to submit thesis before expiry of 15 days of thesis seminar.

Request of aforesaid students is recommended and forward by major/comajor advisor and HoD concerned.

Keeping in view the above, As per Rule 28.4 of Chapter III of University Calendar Volume II, this is reproduced as under:

"The cases which are not covered under the rules but there is sufficient justification for relaxation in the rules, the Dean PGS shall obtain Vice-Chancellor's orders direct. This will, however, be done only in exceptional and extreme emergent circumstances. Gist of all such cases shall be conveyed to the Registrar by the Dean, PGS for submission to the Academic Council through a single item for confirmation."

Hence, as per Rule 28.4 as mentioned above, the relaxation in thesis submission may be granted to the aforesaid students after obtaining the Worthy Vice-Chancellor's orders directly as there is sufficient justification for relaxation in the rules.

Accordingly the case was submitted to the Worthy Vice-Chancellor vide GreenSheet/VB/LUVAS/457/15230/2021-22 dated 13.09.2021 for seeking direct orders of the Worthy Vice-Chancellor regarding relaxation in the gap period of 15 days between delivery of thesis seminar and submission of thesis by PG students. The Worthy Vice-Chancellor has desired that the case may be submitted alongwith recommendations of the RIC in this regard.

Therefore, the case was placed before the RIC for kind consideration and recommendation to obtain direct orders of the Worthy Vice-Chancellor, please.

Afterwards, the RIC considered and discussed the above agenda item and recommended for consideration of all such type of cases only upto the end of this semester i.e. 2<sup>nd</sup> semester of Academic Year 2020-21. The RIC recommended to place the same before the Worthy Vice-Chancellor for approval subject to the ratification by the Academic Council in its ensuing meeting.

The meeting ended with a vote of thanks to the Chair.
