At the outset, the Chairman, welcomed all the Hon'ble members of RIC and special invitees in the 40<sup>th</sup> meeting of Resident Instruction Committee and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and the following decision was taken thereof:

**Agenda item No.40RIC-1: Confirmation of the proceedings of 39<sup>th</sup> meeting of the RIC held on 14.09.2021.**

**Agenda item No.40RIC-2: Action taken report on the proceedings of 39<sup>th</sup> meeting of RIC held on 14.09.2021.**

Noted and approved.

**Agenda Item No.40 RIC-3: Request of Dr. Aman Deep (2019V47M) for submission of thesis – relaxation in Rule 14.6(b) as a special case- ex. post facto approval.**

A request of Dr. Aman Deep, Admn. No. 2019V47M was received by the office of Dean, PGS in which he had stated that he has to apply for the post of Veterinary Surgeon. Therefore, he requested to grant him relaxation for submission of thesis in less than 15 days after the delivery of thesis seminar under Rule 14.6 (b) of Chapter III of University Calendar Volume II which says that the gap between thesis seminar and thesis submission shall not be less than 15 days.

The matter was discussed with the Worthy Vice-Chancellor and relaxation in Rule 14.6 (b) was granted as a special case so that he can apply for the post of Veterinary Surgeon.

In view of above, the RIC considered and discussed the above matter and recommended to place the same before the Worthy Vice-Chancellor for kind consideration and Ex Post Facto approval subject to ratification by the Academic Council in its ensuing meeting, please.

**Agenda Item No.40 RIC-4: Regarding consideration of request from the students of IIVER, Bahu Akbarpur regarding eligibility in M.V.Sc. entrance exam. 2022 & admissions in the Academic Year 2021-22**

This office had received requests from B.V.Sc. internship students duly recommended by The Dean, IIVER, Bahu Akbarpur, regarding consideration of their request to allow them to appear in the Entrance Test for M.V.Sc. programme and at the same time they also requested to consider them for admission in M.V.Sc programme as per their merit during the Entrance Test during 2<sup>nd</sup> semester of Academic Year 2021-22 along with the students of COVSc. LUVAS, Hisar.

In above context, the Worthy Vice-Chancellor desired that the matter may be discussed in RIC Meeting. Therefore, the above matter was placed before the RIC for kind consideration and discussion.

The RIC considered and discussed the above matter at length and was of the view that the B.V.Sc. internship students of IIVER, Bahu Akbarpur may be allowed to appear in the Entrance Test for M.V.Sc. programme to be conducted by LUVAS.

However, as stated by the students of the IIVER, Bahu Akbarpur their internship programme is scheduled to be completed by 20<sup>th</sup> April, 2022 and therefore, as per the eligibility criteria mentioned in PG prospectus 2021-22 they cannot be allowed to take admission in M.V.Sc. programme during 2<sup>nd</sup> semester of Academic Year 2021-22 in LUVAS which is scheduled to be started in March 2022.

However, if any seat remains vacant during the admission process held in March 2022 for admission in M.V.Sc. programme during 2<sup>nd</sup> semester of Academic Year 2021-22, the students may be allowed to take admission in M.V.Sc. programme during 1<sup>st</sup> semester of Academic Year 2022-23 on basis of his/her merit in general merit list during the Entrance Test conducted for admissions in 2<sup>nd</sup> semester of Academic Year 2021-22 provided that he/she meets other eligibility criteria for admission in M.V.Sc. programme as mentioned in PG prospectus 2021-22.

The RIC considered and discussed the above matter at length and recommended to place the same before the Worthy Vice-Chancellor for kind consideration and approval subject to ratification by the Academic Council in its ensuing meeting, please.

**Agenda Item No.40 RIC-5: Refund of fee to Ph.D students who were admitted in Academic Year (2021-22) in LUVAS & later on got admission in other institutes through AICE JRF/SRF (Ph.D)2021 examination.**

This office had received requests from Ph.D. students of LUVAS who got admission during first semester of academic year 2021-22 in October 2021. In this regard they had stated that the counseling and registration in Ph.D. programme in LUVAS was done in October 2021 before the counseling of ICAR for admissions in Ph.D. programmes throughout India through ICAR's AICE JRF/SRF examination which started in December 2021. Now some students have been admitted to other institutes through ICAR and their admission in LUVAS has been cancelled on their own request as per university rules. This mismatch between counseling schedules of the LUVAS and ICAR has been due to COVID-19 circumstances, which is beyond the control of students, the University and the ICAR. Therefore, they had requested for complete refunding of their admission fees.

The refund policy as mentioned in the PG prospectus for the academic year 2021-22 at page number 31 is as under:

**REFUND POLICY**

The fees paid at the time of counselling i.e. at the time of fresh admission shall be refunded according to the following table:
