Due to COVID-19 situation' both the semesters of Academic Year 2021-22 have been slightly squeezed so that the students after passing out their degree can participate in other Entrance Tests and can take admission in ICAR and other institutes. However, to complete the courses the instructors may feel free to take the classes during Sundays and holidays, if they feel so.

**Agenda Item No.41 RIC-5: To Grant Relaxation in Rule 9.4 of Chapter III of University Calendar Volume II to Dr. Tarun Sehgal and Dr. Sandeep Joon.**

Dr. Tarun Sehgal, Admn. No. 2015V06M and Dr. Sandeep Joon, Admn. No. 2015V05M were admitted in M.V.Sc. programme in 1<sup>st</sup> semester of Academic Year 2015-16 in the department of AGB. They were allowed to join service as Veterinary Surgeon in the AH & D Deptt., Govt. of Haryana vide office No. PGS/2017/837-59, dated 04.03.2017. Now, both the students are allowed to re-join their study vide office order No. Dean/PGS/2021/2678-90, dated 16.10.2021 in the 1<sup>st</sup> semester of Academic Year 2021-22.

Dr. Tarun Sehgal and Dr. Sandeep Joon have registered for 16 and 13 credit hours of research respectively. Now, request has been made by them to the Worthy Vice-Chancellor to grant them relaxation in Rule 9.4 of Chapter III of University Calendar Volume II for submission of Thesis seminar certificate along with the result of credit hours of research and also for submission of thesis.

As per Rule 9.4 of Chapter III of University Calendar Volume II:

**Dean, PGS may accept the result up to five credit hours of research along with thesis seminar certificate, panel of examiners and thesis after mid-term examination of last semester of residential requirement. However, further relaxation up to five credit hours may be allowed in very genuine cases by the Dean, PGS.**

Keeping in view of above, the matter was placed before the RIC for kind consideration.

**The RIC considered the above agenda item and unanimously reached to the decision that no relaxation in Rule 9.4 of Chapter III of University Calendar Volume II can be granted to the above mentioned students.**
