## Agenda Item No.40 RIC-3: Change in counseling and registration date for admission of ICAR nominees only, in M.V.Sc. and Ph.D. programmes in the second semester of the academic year 2021-22

As per ICAR's instructions 25 % seats of the accredited programmes needs to be offered as ICAR quota seats by Accredited AUs. The candidates are provisionally admitted against these ICAR quota seats through ICAR's AIEEA (PG) and AICE-JRF/SRF (Ph.D.)-2021 Online counseling, subject to physical verification of documents by the allotted university as per its counseling and registration schedule mentioned in the PG prospectus of that academic year.

Accordingly, the admissions of ICAR nominees who have been provisionally admitted through online counseling of ICAR, in M.V.Sc. and Ph.D. programmes, in the second semester of the academic year 2021-22, at LUVAS, Hisar were scheduled to be held as per counseling and registration schedule given in the PG Prospectus of the academic year 2021-22, which was as follows:

Therefore, in order to be admitted in M.V.Sc. and Ph.D. programmes at LUVAS, Hisar, the ICAR nominees were supposed to produce their PDC/Degree certificates on 14.03.2022.

Now, as per ICAR's notice dated 22<sup>nd</sup> November 2021, all the candidates seeking admissions during academic session 2021-22 through ICAR have been given one time relaxation and are allowed to submit their PDC/Degree certificates at the time of admission/registration in the allotted university as their degree programmes were delayed due to COVID-19 pandemic.

This office also received requests from some students nominated by ICAR for admission in the second semester of Academic year 2021-22 in LUVAS, Hisar, in which they have stated that their B.V.Sc. internship is going to be completed on 15.03.2022 and they will be able to produce their PDC/Degree certificates only after that.

Therefore, keeping in view the present circumstances, it has been proposed to change the date of counseling and registration for admission in M.V.Sc. and Ph.D. programmes, LUVAS for the ICAR nominees only seeking admission in the second semester of the academic year 2021-22.
