Agenda Item No.43 RIC-3: Request of Ms. Kajal Bhardwaj for admission in M.V.Sc. programme in Academic year 2021-22

This office received request from Ms. Kajal Bhardwaj seeking admission in M.V.Sc. programme on 4.3.2022, in which she stated that she is pursuing B.V.Sc. programme and has to appear in the B.V.Sc. internship viva-voce examination at IVRI on 14.3.2022 and therefore will not be able to attend the first counselling in person which was scheduled on same day i.e. 14.3.2022. Now she has submitted letter from her office showing that she has successfully completed the internship programme and all the other requirements for the award of B.V.Sc. degree. Further, she has appeared in the M.V.Sc. entrance examination and her academic merit standing is at serial number 32 in combined merit list and therefore, she has requested to consider her for admission in M.V.Sc. programme during 2nd counselling on 17.3.2022.

Agenda Item No.43 RIC-4: Request of Mr. Sandeep Goyat for admission in M.V.Sc. programme in Academic year 2021-22 during 2nd counselling.

First counselling for admissions in M.V.Sc. programme in 2nd semester of Academic year 2021-22 was held on 14.3.2022. Mr. Sandeep Goyat attended 1st counselling and he was offered admission in the discipline of Veterinary Pharmacology and Toxicology as per roaster system and in accordance with his academic merit. However, the medical examination of some candidates including Mr. Sandeep Goyat could not be conducted on same day due to closing of Campus Hospital. All candidates were informed to deposit the fee first on 14.3.22 itself and to get them medically examined on 15.3.22. However, the office of Dean PGS could not contact Mr. Sandeep Goyat telephonically due to network issues. Therefore, he could not deposit the fee on same day and as per point 5.9 of PG Prospectus for the 2nd semester of academic year 2021-22 his admission could not be confirmed. Now he has requested to consider him for admission in M.V.Sc. programme during 2nd counselling on 17.3.2022 as per his academic merit standing as he was not at fault.
