At the outset, the Chairman, welcomed all the Hon'ble members of RIC and special invitees in the 46th meeting of Resident Instruction Committee and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and the following decisions were taken thereof:

Agenda item No.46RIC-1:	Confirmation of the proceedings of 45 th meeting of the RIC held on 08.04.2022. Confirmed.
Agenda item No.46RIC-2:	Action taken report on the proceedings of 45 th meeting of RIC held on 08.04.2022. Noted and approved.
Agenda Item No.46 RIC-3:	Request of Mr. Aurnpreet Singh, Admn. No. 2019V46M regarding grant of permission for thesis submission under mercy appeal on symphatic ground.

The RIC discussed the above matter at length and recommended that the last/final chance for thesis submission may be granted to Mr. Aurnpreet Singh, Admn. No. 2019V46M on the sympathetic ground. The request of Mr. Aurnpreet Singh is considered as a special case and the reference of this case will not be used in future. The members of RIC are of view that the final extension may be granted to him after taking in view the mercy appeal of the student with the following conditions that

- He has to register himself as a special case after the regular date of the registration of 6th semester with full semester fee and extension fees within seven days of issuance of order.
- 2. After registration he has to re-deliver his thesis seminar within two weeks of registration.
- 3. The thesis will be submitted by the concerned student by the prescribed date of thesis submission for the current semester i.e. 26.07.2022.

Afterwards, RIC recommended that the same may be placed before the Worthy Vice-Chancellor for kind consideration and approval subject to the ratification by Academic Council in its ensuing meeting.

Agenda Item No.46 RIC-4: Request of Dr. Rakesh Kumar, Admn. No. 2020V14D regarding refund of fee in reference to CWP No. 25827.

Dr. Rakesh Kumar, Admn. No. 2020V14D could not join classes due to nonissuance of final NOC/relieving order by the department during his admission in 2nd semester of the academic session 2020-21 and he filed a case **CWP No. 25827 of 2021** in the Hon'ble High Court of Punjab and Haryana at Chandigarh against State of Haryana (Director-General, Department of Animal Husbandry and Dairying, Haryana, sector-2, Panchkula) and others regarding the final NOC. The Hon'ble Punjab and Haryana high court had disposed of the case vide date of decision 17.12.2021 with an expectation that respondent No. 4- University will take a lenient view qua the deposit of fee by the petitioner (i.e. Rakesh Kumar), being a government servant, he has to necessarily depend on the competent authority for requisite permission and for no fault of his he ought not be put to financial hardship by forfeiture of the fee deposited by him, while final NOC was pending.

In view of above, the RIC discussed the above matter at length, in view of the decision of Hon'ble Punjab & Haryana High Court, it was decided to refund full fee to the petitioner (i.e. Dr. Rakesh Kumar, Admn. No. 2020V14D) which was deposited by him at the time of admission.
