Agenda Item No.47 RIC-4: Regarding consideration of Rule 27.2(a)(ii) of Chapter III of University Calendar Volume II of LUVAS.

Rule 27.2(a)(ii) of Chapter III of University Calendar Volume II is reproduced as under:

“A Ph.D. Student appointed as Junior Research Fellow / Senior Research Fellow at the LUVAS main campus may be permitted to join the same, if the fellowship is in the same discipline, after completing his / her PCE and course requirements, without dropping the studies”.

As mentioned in above quoted rule, a Ph.D. student may be permitted to join Junior Research Fellow / Senior Research Fellow at the LUVAS main campus but student can not be permitted to join as JRF/SRF in institution other than LUVAS due to the provision contained under the University Rules.

There is a request from a Ph.D. student who has got opportunity to join JRF/SRF in institution outside the LUVAS main campus carrying out the research work in collaboration with Co-Major Advisor at ICAR-CIRB, Hisar. If allowed for the same, it will provide financial help to the student and will encourage her to work with great enthusiasm which will result in good research work and publications. This will also be in the interest of the student as well as the University.

The above matter was discussed at length and all the RIC members were of the view that the matter should be examined in detail. In view of this the RIC proposed a committee for further examination of the issue with the following members:
