**Agenda item No.49RIC-2: Action taken report on the proceedings of 48<sup>th</sup> meeting of RIC held on 07.07.2022.**

**Agenda Item No.49 RIC-3: Regarding consideration of Rule 27.2 of Chapter III of University Calendar Volume II of LUVAS.**

Rule 27.2(a)(ii) of Chapter III of University Calendar Volume II is reproduced as under:

***“A Ph.D. Student appointed as Junior Research Fellow / Senior Research Fellow at the LUVAS main campus may be permitted to join the same, if the fellowship is in the same discipline, after completing his / her PCE and course requirements, without dropping the studies”.***

As mentioned in above quoted rule, a Ph.D. student may be permitted to join Junior Research Fellow / Senior Research Fellow at the LUVAS main campus but student can not be permitted to join as JRF/SRF in institution other than LUVAS due to the provision contained under the University Rules.

There is a request from a Ph.D. student who has got opportunity to join JRF/SRF in institution outside the LUVAS main campus carrying out the research work in collaboration with Co-Major Advisor at ICAR-CIRB, Hisar.

The matter of above agenda item was discussed in the 47<sup>th</sup> meeting of RIC held on 04.07.2022 in the office of Dean, PGS and proceedings of meeting were circulated by this office vide office Endst. No. RIC/PGS/2022/2303-18, dated 04.07.2022. The matter was discussed at length and all the RIC members were of view that the matter should be examined in detail.

In view of this the RIC proposed a committee for further examination of the issue with the following members:

The case for approval of committee recommended by RIC was placed before the worthy Vice-Chancellor vide digital Green Sheet/DP/LUVAS/238/18330/2022-23, dated 04.07.2022 and the same was approved after adding Dean, COVS as member in the above mentioned committee.

Accordingly, office order vide No. LUVAS/PGS/Acad./2022/2244, dated 06.07.2022 was circulated by the office of Dean, PGS for information of committee members. Thereafter, a meeting of committee was held on 15.07.2022 to re-visit the Rule 27.2 (a) of Chapter III of University Calendar Volume II.

The committee discussed the Rule No. 27.2 (a) and (b) in Chapter III of the University Calendar Volume II at length and unanimously resolved to recommend the followings amendments in this rule:
