At the outset, the Chairman, welcomed all the Hon'ble members and special invitees and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and the following decisions were taken thereof:

Dr. Rajan Papneja, Admn. No. 2020V11M was admitted to M.V.Sc in 2<sup>nd</sup> semester of the Academic session 2020-21 in the department of Animal Nutrition. Dr. Sajjan Sihag, Principal Scientist was allotted as Major Advisor. It is submitted by the Major Advisor of the student that after discussion with Commandant, Equine Breeding Stud, Hisar, research problem/synopsis for M.V.Sc. programme for the student was proposed as **"Effect of feeding soybean (Glycine max) on performance of sessionling horses".** Accordingly, the synopsis of the student was approved by the office of Dean, PGS vide Memo. No. Dean/PGS/2022/1101-1103,dated 25.03.2022 before the registration date of 3<sup>rd</sup> semester on the above said topic under the provision contained in **Rule 14.1 (a) of Chapter III of University Calendar Volume II.** 

In view of above, the student has to conduct the research work of approved synopsis in the **Equine Breeding Stud (EBS)** and a letter for obtaining the permission to conduct research on Equines at EBS, Hisar was forwarded by the Major Advisor vide No. AN/2022/540-541, dated 12<sup>th</sup> May 2022. In reply of this, a letter was received from Equine Breeding Stud vide no. 512/5/HS, dated 14<sup>th</sup> July, 2022, wherein it is mentioned that the proposed draw down plan and downsizing of EBS, Hisar in near future Dte Gen RVS has not approved for conduct of proposed research.

Now, it is submitted by the Major Advisor of the student that after telephonic conversation with the office of EBS, he has come to know that the horses can be

shifted to other center at any time and it will be risky for completing the proposed research work.

Therefore, in this regard, the meeting of Advisory Committee of **Dr. Rajan Papneja was held on 15.07.2022** in the office of the Head, Deptt. of Animal Nutrition to discuss his synopsis for research work to be carried out. After discussion the committee decided to change his research work for his M.V.Sc programme and approved research topic for his M.V.Sc. synopsis entitled "Effect of supplementing **Probiotics and Prebiotics on Performance of Rabbits**"

In above context, it is pertinent to mention here that as per past practice the minor changes in the synopsis of PG students are being approved by the Dean, PGS on the recommendation of Advisory Committee, Major Advisor and Head, of the Department. Now, the changes in the revised synopsis of M.V.Sc student Dr. Rajan Papneja has been recommended by the Major Advisor and HoD are of Major Nature and may be approved with permission of competent authority.

Taking under consideration the above explained actualities, the RIC agreed to change the synopsis of Dr. Rajan Papneja, Admn. No. 2020V11M.

Further, the RIC recommended to place the matter before the Worthy Vice-Chancellor for granting necessary approval subject to the ratification by the Academic Council in its ensuing meeting.

## Agenda Item No.50 RIC-4: Minor changes in the M.V.Sc. admission policy for vacant seats of the 2<sup>nd</sup> semester 2021-22 for admission in 1<sup>st</sup> semester of academic session 2022-23.

The PG (M.V.Sc.) prospectus for admission to M.V.Sc. programme in 2<sup>nd</sup> semester of academic session 2021-22 was uploaded on the University website and accordingly, the admission process was conducted in March, 2022 for the said programme. After admission of all the eligible candidates, 21 (twenty one) seats remained vacant in various disciplines.

The provision contained under Rule 1.1(x) of Chapter-III in PG (M.V.Sc.) Prospectus 2021-22 for admission to M.V.Sc programme in 2nd semester (2021-22) is reproduced as under:

The students from IIVER Bahu Akbarpur (Rohtak) who are currently registered for their internship programme are allowed to apply and appear for entrance test to be held on 06.03.2022. However, they will not be considered for M.V.Sc. admissions during the 2<sup>nd</sup> semester of academic session 2021-22, if their degree is not completed by the day of counseling but if any seat remains vacant during the admission process held in March 2022 for admission in M.V.Sc. programme during 2<sup>nd</sup> semester of Academic Session 2021-22, the students may be allowed to take admission in M.V.Sc. programme during 1<sup>st</sup> semester of Academic Session 2022-23 on basis of his/her merit in general merit list during the Entrance Test conducted for admissions in 2<sup>nd</sup> semester of Academic Session 2021-22 provided that he/she meets other eligibility criteria for admission in M.V.Sc. programme as mentioned in PG (M.V.Sc.) prospectus 2021-22.

As per position explained above, the candidates from IIVER, Bahu Akbarpur (Rohtak) who were registered for their internship programme were allowed to apply and appear for entrance test held on 06.03.2022. Now, the eligible candidates may be admitted to M.V.Sc programme in 1<sup>st</sup> semester of the academic session 2022-23 as per their entrance test merit plus weightage, if any subject to the conditions mentioned in PG (M.V.Sc.) prospectus for admission to M.V.Sc. programme in 2<sup>nd</sup> semester of academic session 2021-22.

In above context, a notice for M.V.Sc. counselling has been uploaded on University website for information of the eligible candidates seeking admission to M.V.Sc programme with the approval of competent authority of the University.

Now, some candidates who appeared in Entrance Test held on 06.03.2022 have requested that their candidature may also be considered for the admission to M.V.Sc. programme in 1<sup>st</sup> semester of Academic Session 2022-23 against vacant seats during the admission in 2<sup>nd</sup> semester of Academic Session 2021-22 alongwith the candidates of IIVER Bahu Akbarpur (Rohtak).

In view of above, the M.V.Sc. counselling notice already uploaded on University website has been withdrawn with the approval of competent authority alongwith the permission to display the notice to postpone the M.V.Sc. counselling schedule on 25.08.2022 and to put up the matter in RIC for consideration.

As mentioned above, 21(twenty one) seats remained vacant during admission to M.V.Sc. programme in 2<sup>nd</sup> semester of academic session 2021-22, therefore, all the eligible candidates may be allowed to participate in counselling for admission to M.V.Sc. programme in 1<sup>st</sup> semester of academic session 2022-23 against these vacant seats alongwith the candidates of IIVER, Bahu Akbarpur (Rohtak).

In view of the above explained facts, it was proposed to consider the minor changes in the admission policy mentioned under rule1.1(x) of Chapter-III in PG (M.V.Sc.) Prospectus 2021-22 for admission to M.V.Sc programme in 2nd semester (2021-22):

However, they will not be considered for M.V.Sc. admissions during the 2 <sup>nd</sup> semester of academic session 2021-22 if their degree is not completed by the day of counseling but if any seat remains vacant during the admission process held in March 2022 for admission in M.V.Sc. programme during 2 <sup>nd</sup> semester of Academic Session 2021- 22, the students may be allowed to take admission in M.V.Sc. programme during 1 <sup>st</sup> semester of Academic Session 2022-23 on basis of his/her merit in general merit list during the Entrance Test conducted for admissions in 2 <sup>nd</sup> semester of Academic Session 2021-22 provided that he/she meets other eligibility criteria for admission in M.V.Sc. programme as mentioned in PG (M.V.Sc.) prospectus 2021-22.	1.1(x) The eligible candidates who qualified entrance test held on 06.03.2022 for admission to M.V.Sc. programme in the 2 <sup>nd</sup> semester of the academic year 2021-22 and could not get admission, may participate in the counselling for admission to M.V.Sc. programme during 1 <sup>st</sup> semester of the academic year 2022-23 against seats remaining vacant after last counselling of 2 <sup>nd</sup> semester 2021-22, if any.	

The RIC discussed the matter at length and approved the above said amendment in the PG prospectus of 2021-22.

Further the RIC authorized Dean, PGS to conduct the counselling as per convenience of the Dean, PGS office and if required the 2<sup>nd</sup> counselling may also be conducted after obtaining the necessary permission from the competent authority.



In view of above, the RIC recommended to place the matter before the Worthy Vice-Chancellor for granting necessary approval subject to the ratification by the Academic Council in its ensuing meeting.

The meeting ended with a vote of thanks to the Chair.
