Agenda Item No.51 RIC-3: Permission for discontinuation of M.V.Sc. programme

(VPHE) to Dr. Priyanka Sheoran, Admn. No. 2020V52M

Dr. Priyanka Sheoran, Admn. No. 2020V52M was admitted to M.V.Sc in 2nd semester of the academic year 2020-21 in the department of Veterinary Public Health and Epidemiology. She has completed three semesters successfully and now, she is enrolled in 4th semester (First semester of 2022-23) of her residential requirements of M.V.Sc programme. She has completed all the credit hours of course work and also completed 17 credit hours of research out of 20 credit hours.

Now, she has submitted an application in which she has stated that she got selection in Commonwealth Shared Scholarship for doing M.Sc. Wildlife Conservation in University of Chester, Chester, United Kingdom and classes for M.Sc. in University of Chester is to be started from 10th October, 2022. Hence, she has requested to grant her permission for discontinuing her M.V.Sc. programme of LUVAS, Hisar.

The case of Dr. Priyanka Sheoran for discontinuation of M.V.Sc programme (VPHE) in her 4th semester of residential requirements has been recommended and forwarded by the Professor and Head, Deptt. of Veterinary Public Health and Epidemiology vide Green Sheet/PE/LUVAS/1136/19008/2022-23, dated 07.09.2022 for sympathetically consideration. The same case has been recommended and forwarded by Head, Deptt. of Veterinary Public Health and Epidemiology vide Green Sheet/PE/LUVAS/1145/19129/2022-2023, dated 17.09.2022 to Dean, PGS to allow Dr. Priyanka Sheoran to discontinue the study from 17.09.2022.

Whereas, as per provision contained under Rule 27.2 (b) (i) of Chapter III of University Calendar Volume II which is reproduced as under:

The M.V.Sc. students who have completed all the credit hours of course work and atleast 50% of research work and are in 4th semester to fulfill his / her residential requirements, may be allowed to join service by Dean, PGS and will be allowed to re-join their studies excluding the semester in which he /



she had joined service, on production of 'NOC' from the employer within the prescribed time period. He / She will be allowed to re-join service after submission of thesis.

In view of the above, there is no provision under University rules regarding the permission to the M.V.Sc students for discontinuation of his / her study for aforesaid purpose.

Therefore, the agenda item was placed before the RIC for kind consideration and decision. The RIC discussed the matter at length and proposed following amendment in the Rule No. 27.1 and 27.2 of Chapter III of University Calendar Volume II:

He / She will be allowed to re-join service after submission of thesis. (ii) The dropping may be allowed subject to the condition of completion of the programme within the time limit already prescribed for completion of Master's programme and no extension in the period will be given.	(i) The Master's students who have completed three semesters of his/her programme, all the credit hours of course work and at least 50% of research work may be allowed to join service by Dean PGS and will be allowed to re-join their studies excluding the semester in which he / she had joined service, on production of 'NOC' from the employer within the prescribed time period. He / She will be allowed to re-join service after submission of thesis. (ii) The discontinuation may be allowed subject to the condition of completion of the programme within the time limit already prescribed for completion of Master's programme and no extension in the period will be given. Note: Under exceptional circumstances for some extra-ordinary academic achievement, a student may be allowed to discontinue his / her Master's studies after having completed three semesters of his/her programme, all the credit hours of course work and at least 50% of research work. He / She may be allowed to re-join study excluding the semester in which he / she discontinued. However, in case of extra-ordinary academic achievement, the prior approval of Vice Chancellor is to be obtained.



Further RIC recommended to place the matter before the worthy Vice-Chancellor for granting necessary approval subject to the ratification by the Academic Council in its ensuing meeting.

Agenda Item No.51 RIC-4:

Approval of revised programme of work (POW) in respect of M.Tech. (Dairy Engineering) Student Mr. Rohit, Admn. No. 2020DT05M.

Mr. Rohit, Admn. No. 2020DT05M was admitted to M.Tech. in 2nd semester of the academic year 2020-21 in the department of Dairy Engineering. He has completed three semesters successfully and now, he has been enrolled in 4th semester of his residential requirements of M.Tech. programme.

The Programme of Work (POW) in respect of Mr. Rohit has approved by the Dean, PGS in 1st semester of his residential requirements. Now, the Major Advisor of the student submitted that Programme of Work of M.Tech.(Dairy Engineering) student Mr. Rohit, Admn. No. 2020DT05M was submitted to the office of Dean, PGS within the time frame, but due to some mistake and being first student registered for M.Tech. programme, the pre-requisite courses as approved for discipline of Dairy Engineering were not included in the Programme of Work. Hence, the revised Programme of Work after including the pre-requisite courses has been submitted to the office of Dean, Post Graduate Studies for approval in 4th semester (i.e. 1st semester of Academic Year 2022-23) of his residential requirements.

Now, a case for special permission for revision of Programme of Work with addition of pre-requisite courses of M.Tech. (Dairy Engineering) in respect of aforesaid student has been received by the office of Dean, PGS recommended and forwarded by the Dean, CoDST, LUVAS vide Green Sheet/DD/LUVAS/619/19049/2022-2023, dated 12.09.2022. The pre-requisite courses for M.Tech. programme in the discipline of Dairy Engineering has been offered by the CoDST, LUVAS for the 1st semester of Academic Year 2022-23.

As per provision contained under Rule 5.6(a) of chapter III of University Calendar Volume II, LUVAS:

Major Advisor will ensure that the programme of Work (form PG-2) must be submitted and got approved by the students through HoD from the Dean, PGS till the end of 1st semester after admission.

In view of the above, the matter of approval of revised Programme of Work (POW) in respect of Mr. Rohit, Admn. No. 2020DT05M can not be considered at this stage as per University rules.

Therefore, the matter was placed before the RIC for consideration and decision. The RIC discussed the matter at length and decided that Revised Programme of Work (POW) in respect of Mr. Rohit, Admn. No. 2020DT05M may be approved in 4th semester of his residential requirements as a special case. The RIC also decided that this case will not be used as precedent in future.

Further, the RIC recommended to place the matter before the Worthy Vice-Chancellor for granting necessary approval subject to the ratification by the Academic Council in its ensuing meeting.

The meeting ended with a vote of thanks to the Chair.
