Agenda Item No.55 RIC-3: Correction of PG seats in the Prospectus 2022-23.

Due to inadvertent discrepancy in the number of seats mentioned at page number **63** and **61** of **Chapter V** of Prospectus **2022-23**, there is a need of issuance of corrigendum in respect of category wise distribution of seats for M.V.Sc. and Ph.D. programme. The number of seats for admission to M.V.Sc. programme mentioned at page no. 61 is **37(thirty seven)** for Haryana residents candidates, whereas, inadvertently 47 seats distributed as per roster among the different categories of the Haryana residents candidate as mentioned at Sr. No. 7 of page No. 63 of Prospectus 2022-23. Actually the number of seats mentioned at page **61(copy attached)** of Prospectus 2022-23 are approved by BOS and RIC and subsequently approved by the Academic Council vide **Suppl. Agenda Item No. 59A-1** in its **59th meeting** held on **05.07.2022**, but the same correction was not applied at **Sr. No. 7** on page **63 (copy attached)** for distribution of category wise seats for admission to **M.V.Sc.** Programme.

In view of the above the category wise seats as mentioned on page no. 63 for M.V.Sc. Programme should be read as given below instead of already given in Prospectus 2022-23:

*Total fifty percent (50%) of Scheduled Castes Seats will be reserved for Deprived Scheduled Castes Candidates.

Similarly, the seats mentioned for Haryana Resident Candidates for **Ph.D.** Programme on page no. **61 and 65** are different, therefore the number of seats for Haryana Resident Candidates at **Sr. No. 8** on page no. **65 (copy attached)** of Prospectus 2022-23 should be read as **18 instead of 20**.

In view of the above, the matter was placed before the RIC for consideration and discussion.

The RIC discussed the matter at length and recommended to place the same before the Worthy Vice-Chancellor for approval subject to the ratification by the Academic Council in its ensuing meeting.
