At the outset, the Chairman, welcomed all the Hon'ble members and special invitees and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and the following decisions were taken thereof:

Dr. Sonu Kumari, Admn. No. 2019V10D admitted to Ph.D. programme in the 1<sup>st</sup> semester of Academic Year 2019-20 in the Deptt. Of Veterinary Gynecology and obstetrics. Now, she has submitted an application duly recommended by the HoD, VGO (copy attached at Annexure-1) regarding the extension of time period for submission of thesis. Wherein she stated that due to COVID, only research work was completed and thesis seminar was delivered by her. Thereafter, she gave birth to a baby and was unable to write the thesis during this period.

In view of the above, clarification has been asked by the office of Dean, PGS vide Memo. No. LUVAS/PGS/Acad/2023/349, dated 20.02.2023 (copy attached at Annexure-2) regarding the reason of non-submission of thesis in stipulated time period i.e. six month from the date of delivery of thesis seminar and thereafter, the permission for extension in thesis submission was not sought from the office of Dean, PGS.

In the above context, she has submitted her point wise reply through HoD, VGO vide Document No.:-GY1555-030323 (Copy attached at Annexure-3).

After examining the case, it's found that she was admitted to Ph.D. Programme in the Deptt. of **Veterinary Gynecology and Obstetrics** as in-service candidate in 1<sup>st</sup> semester of Academic Year 2019-20 and delivered her thesis seminar on 09.05.2022 in 2<sup>nd</sup> semester of Academic Year 2021-22(i.e. 6<sup>th</sup> sem. of her study).









As per rule 14.6(b) of chapter III of University Calendar Volume II which is reproduced as under:

Master's and Ph.D. students can submit the thesis only in the last semester of residential requirement. After delivering thesis seminar, Master's and Ph.D. students should submit their thesis within three and six months respectively. This period can be extended by the Dean, PGS for three months in both the cases. There should be a minimum gap of 15 days in between thesis seminar and thesis submission.

But she has not submitted her Ph.D. thesis within six months from the date of delivery of thesis seminar and further, the extension of three months was not sought by her from the Dean, PGS office.

In view of the position explained above, the matter was placed before the RIC for kind consideration and decision, please.

The RIC discussed the matter at length and all the members of RIC unanimously resolved that Dr. Sonu Kumari (2019V10D) may be allowed to submit the thesis with the following conditions:

She should register in the next semester i.e. 8<sup>th</sup> semester of her study after paying the requisite fee and availing the appropriate leave. Thereafter she will have to re-deliver the thesis seminar and submit the thesis as per existing rules. She will be allowed to join service after submission of thesis.

Further, the RIC recommended to place the matter before the worthy Vice-Chancellor for approval and obtaining necessary permission to issue orders subject to ratification by the Academic Council its ensuing meeting, please.

#### Agenda Item No.56RIC-4: To discuss the issues regarding the award of Merit Gold Medal

The matter regarding the award of Merit Gold Medal to Masters' and Doctorates' students was placed before the 54<sup>th</sup> meeting of RIC held on 12.01.2023. Further, the RIC discussed the matter at length and proposed a committee to examining the issues regarding the award of Merit Gold Medal.

In view of the above, the matter was placed before the worthy Vice-Chancellor for approval of the proposed committee vide Green Sheet/DP/LUVAS/266/20404/2022-23, dated 16.01.2023 and same was approved by him with the comments that Dean, PGS will be Chairman of the Committee.

Subsequently, the order was circulated by the Dean, PGS office vide office Endst. No. LUVAS/PGS/Acad/2023/157-61, dated 17.01.2023 (copy attached at Annexure - 4) regarding the constitution of committee.

Thereafter, the committee in its meeting held on 02.02.2023 and 17.03.2023 discussed the issues regarding the award of Merit Gold Medals to the Masters' and Doctorates' students at length and recommended the guidelines to be followed for the award of the above said gold medal. The recommendation of the committee is **attached at annexure-5**.

In view of the position explained above, the matter is placed before the RIC for consideration and decision.

The RIC accepted the recommendation of the committee and recommend to place the matter before the ensuing meeting of Academic Council for discussion and decision.
