At the outset, the Chairman, welcomed all the Hon'ble members and special invitees and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and the following decisions were taken thereof:

**Agenda item No.57 RIC-1: Confirmation of the proceedings of 56<sup>th</sup> meeting of the RIC held on 18.03.2023.**

**Agenda Item No.57RIC-3: To consider the request of candidates regarding the relaxation in the minimum qualifying marks in the NTA-ICAR-AIEEA (PG)-2022 for M.V.Sc. and NTA-ICAR-AICE (Ph.D.)-2022 for Ph.D. for admission in 2<sup>nd</sup> semester 2022-23.**

Some candidates who have applied for admission to PG programme (M.V.Sc. and Ph.D.) in 2<sup>nd</sup> sem. 2022-23 submitted the applications (**copy attached**) for relaxation in minimum qualifying marks in the NTA-ICAR-AIEEA (PG)-2022 for M.V.Sc. and NTA-ICAR-AICE- JRF/SRF (Ph.D.)-2022 for Ph.D.

As per LUVAS Prospectus 2022-23 (UG and PG Programmes), minimum qualifying marks for M.V.Sc. in the NTA-ICAR-AIEEA (PG)-2022 is 40 % (38% for SC/ST) and for Ph.D. in the NTA-ICAR-AICE- JRF/SRF (Ph.D.)-2022 is 40%. Further, it is submitted that the admission process for PG Programmes (M.V.Sc. and Ph.D.) has already been completed after conducting final Mop-up counselling for Ph.D. and M.V.Sc. on 17.03.2023 at 9:30 A. M. and 2:30 P. M. respectively.

During the admission process, total 38 students (including one J&K Resident and one Kashmir Migrant) admitted for M.V.Sc. programme and 11 students (including 3 supernumerary seats for LUVAS faculty) admitted for Ph.D. programme in 2<sup>nd</sup> semester of Academic Year 2022-23.

After conducting final Mop-up counselling, total 19 seats (9 seats of Vety. Science, 5 seats of Animal Science and 5 seats of Animal Biotechnology & Biochemistry) of M.V.Sc. Programme and 27 seats of Ph.D. Programme remained vacant due to unavailability of eligible candidates.

This is for first time when the admission in M.V.Sc. and Ph.D programmes in 2<sup>nd</sup> semester of Academic Year 2022-23 has been made on the basis of National Testing Agency (NTA) Examination for Indian Council of Agricultural Research.

In view of the above, the matter was placed before the RIC for kind consideration and decision.

The matter was discussed in the RIC at length and unanimously it was resolved:

- i) To relax minimum qualifying marks in the NTA-ICAR-AIEEA (PG)-2022 conducted by the NTA for ICAR to be 30% (28.5% for SC/ST) instead of 40% (38% for SC/ST) for M.V.Sc. and minimum qualifying marks in the NTA-ICAR AICE (All India Competitive Examination JRF/SRF(Ph.D.))-2022 conducted by the NTA for ICAR to be 30% instead of 40% for Ph.D. admissions for the remaining vacant seats of the M.V.Sc and Ph.D. of the academic year 2022-23 for which admissions are to be made during the 2<sup>nd</sup> Semester of 2022-23. The other conditions as mentioned in the prospectus 2022-23 will remain the same.
- ii) The eligible candidates because of changed criteria should be allowed to apply for admission to M.V.Sc and Ph.D. programmes as per convenience of the Dean PGS office.
- iii) The M.V.Sc. vacant seats reserved for any category have been converted to open (General) quota seats during the Final Mop-up counselling, so the vacant seats during the Final Stray Round Counselling will be filled up from the overall merit list of the eligible candidates.
- iv) The RIC authorised the Dean PGS to conduct the Final Stray Round of Counselling as per convenience of the PGS office after obtaining the approval from Worthy Vice Chancellor.
- v) The RIC also recommended that the already admitted candidates will not be allowed to participate in the Final Stray Round of Counselling.
- vi) Since the classes for the 2<sup>nd</sup> Semester 2022-23 has commenced w.e.f. 19.04.2023, the attendance for the candidates admitted in the Final Stray Round of Counselling will be counted from the date of their registration.

**The RIC further recommended for placing matter before the Worthy Vice Chancellor for approval subject to the ratification in the next academic council meeting.**

The meeting ended with a vote of thanks to the Chair.
