Item No. 3 Inclusion of course No. AB-707 (Advances in Animal Biotechnology) in the Course Catalogue :


As per the new course curriculum devised by BSMA, the Department of BMB has proposed a course (No. MBB-607 – Advances in Animal Biotechnology – 2+0, to be offered by the Department of Animal Biotechnology). The house approved the inclusion of a new course ABT-707- Advances in Animal Biotechnology in the new course curriculum of PG. This course is to be cross-listed with MBB-607. The contents will remain the same as that of MBB-607. Further, it was approved that the courses ABT-608 and ABT-616 be cross listed with MBB-555/BIF-501 and MBB-511, respectively.


Item No. 4 Any other item with the permission of the chair :

i) **Cross listing of Course No. MBB-512/Biochem. - 506 with Vety. Microbiology course :** Since the Course contents of any of the Vety. Microbiology Courses do not match *in toto* with the above courses, it was proposed that the Dept of Vety. Microbiology may devise a new course exclusively for the students of COBS and the same may be submitted again to BOS after getting it approved from the Departmental Committee.

ii) **Enhancement of qualification for admission to VLD Diploma course :** The matter regarding enhancing the qualification for admission to VLD Diploma course, from Matriculation to 10+2 with reference to a recent DO letter No. 2267 dated 08.03.2010 from the Director –General, Animal Husbandry & Dairying, Haryana, was discussed at length. In view of the facts that the changed/ enhancement of qualification at this juncture will be a great setback to the fresh Matriculates of this year and inservice candidates of the CCSHAU and State Animal Husbandry Departments of Haryana and Delhi (being not prepared for a sudden change), it was recommended that *status quo* be maintained for this year and the enhanced qualification (10+2) for VLD Diploma course be considered for implementation from the next year (2011-12) after finalizing the issue at various levels and notifying the same well in advance.


