At the outset, the Chairman welcomed all the members of Board of Studies and the following decisions were taken:

Item No.1: Confirmation of the proceedings of the 211th meeting (except Item No.6) of Board of Studies, COVS held on 26.3.2011 at 11.30 a.m.

Confirmed (except item No.6).

Item No.2: Approval of Prospectus for the admission of B.V.Sc.& A.H., MVSc and Ph.D. Programmes.

The prospectus for the admission to the BVSc&AH, MVSc and Ph.D. Programmes was discussed at length and the members pointed out some suggestions/ corrections and the prospectus was approved after the incorporating these suggestions/ corrections.

Item No.3: Approval of Prospectus for the admission to the VLD Diploma Programme.

The prospectus for the admission to the VLD Diploma Programme was discussed in detail and it was approved that the minimum eligibility qualification for appearing in the Entrance Test to this programme will be 10+2 (pass) from any stream i.e. Arts, Science, Commerce or any other stream. A few corrections/ suggestions were made by the members and these suggestions were incorporated and the prospectus for admission to this programme was approved by the members.

Item No.4: Deletion of Post Graduate Diploma in “Livestock Extension Management-through Distance Learning Mode” for the time being.

The modalities proposed for the Post Graduate Diploma in “Livestock Extension Management-through Distance Learning Mode” were discussed at length but there was one constraint that for starting any diploma programme through Distance Learning Mode, permission is required from the Directorate of Distance Learning which was not obtained till date. Since the time left for obtaining the permission from the Directorate of Distance Learning was too short, therefore, it was decided that the starting of this Diploma programme may be deferred for the next academic year. Dr.S.P.Singh was requested to take permission from the Directorate of Distance Learning Mode for starting this Diploma Programme and it was decided that this Diploma programme may be started from the next academic year i.e. 2012-13.

Item No.5. Syllabus for the Entrance Test of VLD Diploma Programme.

In 211th meeting of Board of Studies it was decided that the eligibility qualification for the Entrance Test for the admission to VLD Diploma Programme would be 10+2 pass from any stream i.e. Arts, Science, Commerce or any other stream from a recognized board/ university. In this meeting the syllabus for the Entrance Test of this Diploma Programme

was discussed at length and it was concluded that since several subjects are involved in the Entrance Test, therefore, the syllabus for the Entrance Test of VLD Diploma Programme will be of the matric level from the academic session 2011-12.

Item No.6: Approval of UG & PG Academic Calendar for the year 2011-12.

The Academic Calendar for the academic year 2011-12 of UG & PG Programme was discussed in detail and approved.

Item No.7: Approval of Logo of College of Vety. Sciences, LLRUVAS, Hisar.

The approval of Logo for COVS, LLRUVAS was deferred as it required modifications. It was decided that this item may again be taken up in the next Board of Studies meeting for its approval.
