**Item No.2:** Approval of Logo of College of Vety. Sciences, LLRUVAS, Hisar.




**Item No.3:** Approval of PG Academic Calendar for the year 2011-12.



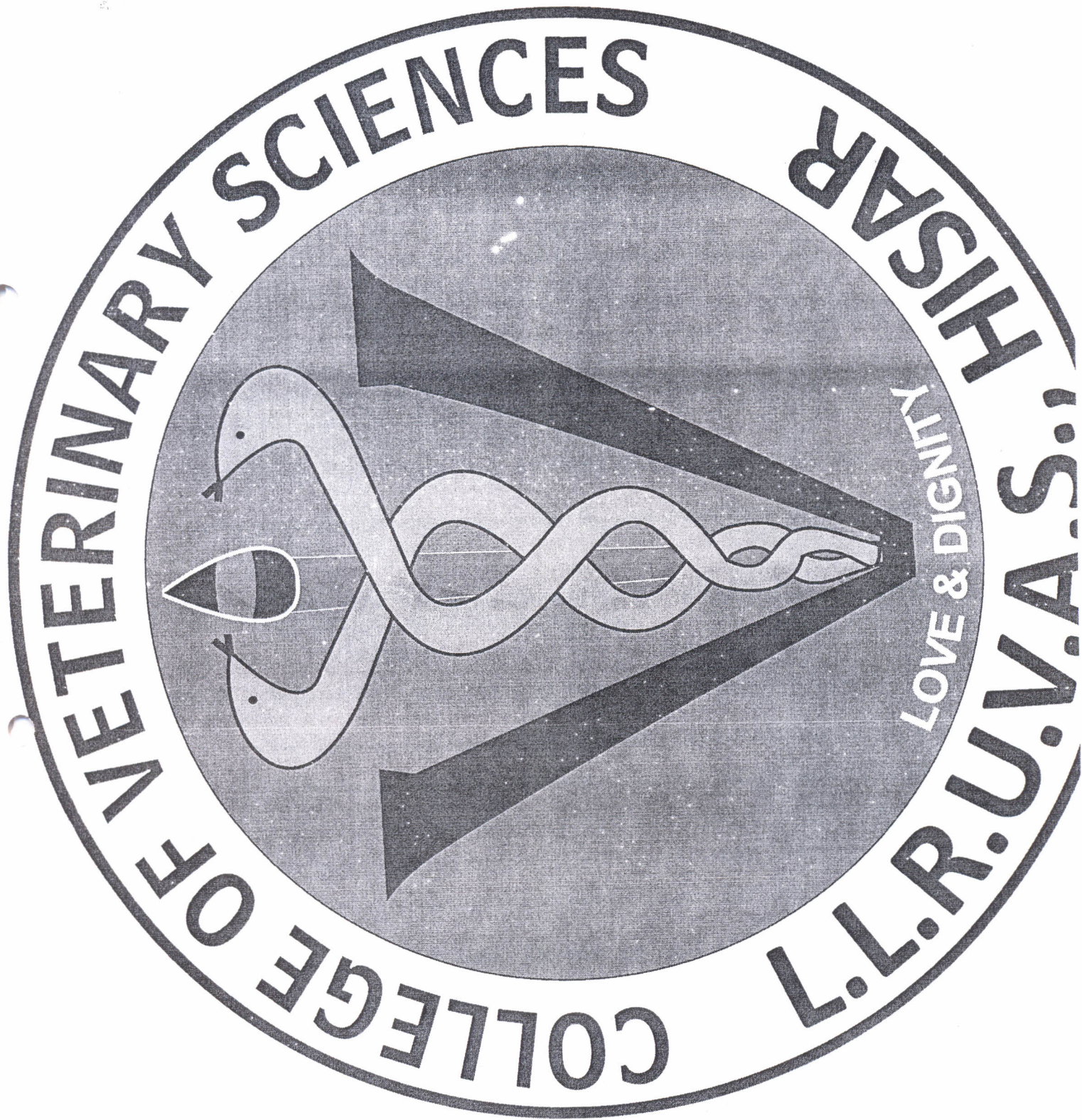
