At the outset, the Chairman welcomed all the members of Board of Studies and the following decisions were taken:

Item No.1: Confirmation of proceedings of 221st meeting of BOS.

Confirmed except item No.6 with respect to Sr. No.3 &4 of Annexure A which were partially modified as under:

'Students studying under old VCI system the distribution of marks in question papers as well as the format and style of question paper will remain unchanged i.e. existing pattern will continue.'

Item No.2: Post Graduate Diploma in Animal Biotechnology

The Prof.& Head, Deptt. of Animal Biotechnology has submitted a proposal to start the Post Graduate Diploma in Animal Biotechnology from the academic year 2012-13. The Departmental Advisory Committee has already approved the course outlines for this Diploma in its 94th meeting held on 17/2/12. The course curriculum for the aforesaid diploma was approved as proposed. Ten seats for this diploma programme have been approved as requested by the HOD, ABT.

Item No.3: Starting of Diploma course entitled "Diploma in Dairy Technology"

The HOD, LPT submitted the revised agenda for Diploma in Dairy Technology. It was approved as proposed. It was further decided that all the faculty members of the department will conduct teaching and other miscellaneous activities in relation to this diploma programme and help from other departments wherever necessary will be rendered.

Item No.4: Change of nomenclature of Postgraduate degrees of the department. The HOD, Veterinary Surgery apprised the members that the existing nomenclature of Postgraduate degrees of the department is MVSc (Veterinary Surgery) and Ph.D (Veterinary Surgery). He submitted the proposal to change the nomenclature as MVSc (Veterinary Surgery & Radiology) and Ph.D. (Veterinary Surgery & Radiology). The proposal was approved as proposed.

Item No.5: Revival of the MVSc programme in Veterinary Immunology discipline The HOD, Vety. Microbiology has submitted a proposal to revive the M.V.Sc. programme in Vety. Immunology discipline. The proposal was approved as proposed.

Item No.6: Revision of qualifications for admission in Ph.D. in Vety. Microbiology and Ph.D. in Vety. Immunology.

The HOD, Vety. Microbiology has submitted a proposal to revise the eligibility for Ph.D. in Vety. Microbiology and Ph.D. in Vety. Immunology as MVSc in Vety. Microbiology/ Vety. Immunology/ Vety. Virology/ Vety.Bacteriology/ Vety. Microbiology & Immunology. The proposal was approved as proposed. In addition, the BOS decided that when the post of Asstt. Prof./Assoc.Prof./Professor and its equivalent is advertised, the eligibility of postgraduate disciplines will be the same as given above for the admission for Ph.D. However, the preference will be given to the concerned discipline.
