4. Sanjay Saini, Admn.No. 2007V50B


**Item No. 4: Method of destruction of secrecy material of examinations such as question papers and answer booklets of the previous years**


It was decided that the destruction of secrecy material such as question paper and answer booklets of the students should continue to be governed under Rule 12 C,


