Item No. 1: Confirmation of proceedings of 230th meeting of BOS held on 23.11.2012 Confirmed

Item No.2: Proposal to increase one seat in Ph. D. programme for admission in Vety.Pharmacology & Toxicology for the IInd Semester (2012-13)

The Board of Studies agreed to create one additional seat in Ph.D programme in Vety. Pharmacology & Toxicology in 2nd Semester 2012-13 only. However the candidate will have to fulfill all the requirements for admission in Ph.D. programme.

Item No. 3: Item No.3 Starting of University Merit Scholarship in DVLT & DIDT on the pattern of VLD Diploma.

The proposal submitted by Dean, COVS was approved by Board of Studies to start a Merit Scholarship in DVLT & DIDT at par with VLD diploma.

Item No.4: Minor changes in Cr.Hrs of DIDT courses.

Approved as proposed.

Item No. 5: Rules & Regulations in VLDD programme.

The Chairman apprised the House regarding guidelines approved by Government of Haryana for diploma courses run by Private Veterinary Institutions in the State. Under these guidelines all the private Veterinary Institutions running diploma courses (VLDD, & DVLT etc.) need to affiliate their Institutions with College of Veterinary Sciences, Hisar and have to follow the course curriculum and rules & regulations for these courses as proposed and approved by College of Veterinary Sciences. The following changes in the existing rules of VLDD course were approved by the Board of Studies.

- i) The medium of instructions will be English instead of Hindi.
- ii) The enrollment with late fee of Rs. 100/- per day may be done upto 15 days instead of Rs. 50/- per day.

Further the Board approved, the imposition of following fee for different activities to be undertaken by the College of Veterinary Sciences, Hisar for Private Veterinary Institutions.

- 1. Affiliation fee Rs. 2.5 lacs and subsequently 0.5 lac every year
- 2. Conduct of entrance examination and counseling fee Rs. 3 lacs, which may be increased during subsequent years.
- 3. Regular examination and evaluation fee Rs. 75,000 per year per class of 60 students

Item No. 6:Admission of in-service candidate in VLDD on the basis of merit in entrance test

The Board of Studies decided that the admission of in-service candidates be done on the basis of marks obtained in the entrance test and the length of service. The modalities for the entrance test will be finalized after taking permission from the concerned authorities.

Item No. 7: Changes in rules & regulations in DVLT & DIDT programme.

With the permission of Chair, Dr.Meenakshi Gupta, Incharge DVLT submitted a proposal for changes in rules & regulations in DVLT & DIDT programme under rule No. 7 regarding examination. The BOS approved the following changes as proposed by Incharge DVLT.

7.3 Existing provision: The examination, theory and practical component of each course shall be conducted separately. Each credit hour of theory as well as practical component will be of 50 marks each.

Proposed provision: Each subject including theory and practical will carry total 100 marks. The weightage of theory and practical of each course will be proportionate to the credit hour of each component.
