**Item No. 2 Prospectus 2013-14 for admission to UG & PG programmes**

The Board of Studies discussed the prospectus for 2013-14 in length and made following observations to be incorporated in the prospectus.

1. Date of declaration of result by 23.6.2013 be added as No.4 at page No -1
2. Date of first counseling be changed to 8.7.2013(Rank No. 1-300) and 10.7.2013 from Rank No. 301 onwards at page No - 1
3. Venue for first counseling be mentioned as Vety. Auditorium COVS at page No -1
4. Venue for first Registration, Second Counseling (cut off date) & Registration be mentioned as Committee Room, Dean COVS.
5. NRIS/IS applicants be deleted at Page No-1 and hereafter in the entire prospectus NRIS/IS be also deleted.

Venue for Registration of NRI –Committee Room Dean, COVS.

6. For NRI, counseling cum Equivalence determination fee should be US \$ 550 at page No – 1. Similar change be made for PG programme at page No. 2 and where ever required in the entire prospectus.
7. Prospectus is to be printed or downloaded or both – to be discussed in Academic Council.
8. Page No. 3, Point No. 6 – Affidavit by the student and an Affidavit by the parents/Guardians is to be added to Annexure XIV, which is required to be filled and submitted at the time of registration. – **Enclosed for inclusion.**
9. Page No. 4 –The Chapter No. V and VI be interchanged and number of annexures need to be examined.
10. Page No. 6 – Introduction of the University need to be recasted.
11. Page No. 7– The objectives of the University mentioned in the prospectus need to be verified from Act of the University.
12. Page No. 7 – Legacy of Pune to be rechecked.
13. Affiliation to PAU in 1960 to be confirmed.
14. Page No. 10, 9<sup>th</sup> line after Annexure-II – Later on if any other board, is not found equivalent for 10+2, certificates issued by such Boards will be invalid and the candidates possessing such certificates will not be eligible for the entrance test. Inadvertently if any such candidate is admitted his/her admission shall be cancelled.
15. Page No. 10, 1.3 b – is to be submitted as an affidavit of gap--recast.
16. Page No. 11 after f – a note is to be added which shall be in the form of an annexure from Head of Institution to be filled in by the candidate of having appeared/appearing in the 10+2 exam as per rule No. 3.2.
17. Page No. 11– Refund policy: as per University calendar needs to be discussed in AC.
18. Page 12, 2.4 – is to be recasted and documents will be returned through Registrar---**through Dean is to be omitted.**
19. Page 12, **2.7 to be added:** The record of E.T exam shall be destroyed after six months of cut off date provided no court case is pending.
20. Page 13, 3.3 – Subject wise questions and marks needs to be changed as marked in the prospectus.
21. Page 15, 4.1 – needs recasting as per counseling dates.
22. Page No. 16: 4.5 – Recast
23. Page No.16 : 4.8 – Recast
24. Page No. 17c – The candidate must have studied in English medium or should submit documentary evidence of proficiency in English language.
25. Page No. 20 – Seats for NRI to be reduced to 5
26. Page No. 24 – Semester tuition fee should be in US \$ and tuition fee for additional semester should also be mentioned in US \$. For PG also semester tuition fee should be mentioned in US \$ and CDF for additional semester should be mentioned in US \$.
27. Page No. 26 – to be deleted

28. Page No. 28, 1.2 – The dates for admission in second semester be mentioned. The downloading of application form mentioned for PG programme need to be discussed in AC.
29. Page No. 28, 4.1– Recast.
30. Page No. 38 – One seat in Ph.D programme in Vety. Pharmacology & Toxicology be enhanced.
31. Page No. 63 – Academic Calendar for B.V.Sc. & AH 2013-14 should be only for 1<sup>st</sup> year or in the existing academic calendar year 5<sup>th</sup> year & internship programme be included.
32. Page No. 64 – Academic calendar for M.V.Sc & Ph.D for fresh admissions and old admissions to be mentioned.
33. Page No. 64 – Last date for submission of synopsis for Ph.D students need to be corrected.
34. Discretionary powers of the Vice-Chancellor where-so-ever mentioned in the prospectus be deleted.
35. Other changes and grammatical mistakes marked in the prospectus be incorporated. **Corrected photocopy of prospectus is enclosed for the Chairman, Prospectus Committee.**

**All the members of the BOS were unanimously of the opinion that sincere efforts should have been put before finalizing the prospectus and sending it to BOS.**
