Agenda Item No.2 Qualification for the post of Assistant Professor, VAHEE

The following qualifications were approved after adding M.V.Sc. in Vety. Extension as suggested by Head, VAHE.

1. B.V.Sc.& AH degree recognized by VCI with minimum 60% marks or 6.0 OGPA on 10.0 point scale.
2. M.V.Sc. in Veterinary and Animal Husbandry Extension/ Veterinary and Animal Husbandry Extension Education/Veterinary Extension Education/ Extension Education/Dairy Extension with minimum 70% of marks or equivalent grade in a point scale where grading system is followed. A master's relaxation of 5% of marks may be provided at the graduate and level for the SC/differently able categories candidates.

Note:

- i. Besides fulfilling the above qualifications candidates should have cleared the NET examination in the concerned discipline/Sub discipline on or before the date of interview.
- ii. Essentially of NET can be waived off for the candidates holding Ph.D degree provided it has been done with course work as prescribed by UGC regulations and the candidate has at least two full length publications having a NAAS rating not less than four on the last date of submission of application. Those candidates with Ph.D without course work will not qualify for NET exemption.

The meeting ended with a vote of thanks to the Chair.


