Agenda Item No. 2. Increased authorization of cadet strength from 200 to 250 under Revised Minimum Standard of Veterinary Education Degree Course (BVSc. & AH) Regulations, 2016 in the LUVAS.

The Board of Studies approved the authorization of cadet strength from 200 to 250, since in new VCI MSVE (BVSc&AH-Degree Course) Regulations, 2016, NCC is compulsory from 1<sup>st</sup> to 3<sup>rd</sup> year.

Further, from Academic Year 2017-18 onwards, the Sports or Cultural activity of 0+1 credit load will be offered to all students of B.V.Sc.&A.H. program under VCI MSVE (BVSc&AH-Degree Course) Regulations, 2016 in LUVAS. NRI and physically disabled students will be offered either Sports or Cultural activity or both of (0+1) x 2 credit load for each professional as NCC is exempted to these students.

In the 241<sup>st</sup> meeting of Board of Studies, one Non-credit course (1+1) in English Language was introduced in 1<sup>st</sup> and 2<sup>nd</sup> Semester of 1<sup>st</sup> year B.V.Sc.&A.H. program w.e.f. Academic session 2015-16 which could not materialize due to non-availability of English teacher.
