Agenda Item No. 1. Confirmation of proceedings of 251st meeting of BOS held on 18.11.2016 at 10:00 A.M.

Agenda Item No. 2. To increase two seats in M.V.Sc programme for admission in Vety. Gynaecology & Obstetrics.

The BOS considered and approved the request of Professor & Head, Dept. of Vety. Gynaecology & Obstetrics for increasing two seats in MVSc. The total no. of seats in MVSc & Ph.D have been, further, included in agenda item no. 7 under supplementary agenda.

Agenda Item No. 3. Reservation of additional one seat in VLD diploma course for residents of village Riwasa, Mahendragarh for offering land for RVDEC on lease basis.

Director, IPVS, LUVAS, Hisar submitted the agenda in reference to letter No. DR/2017/350 dated 14.02.2017 from the Director of Research, LUVAS, Hisar "as per conditions agreed upon by competent

authorities 0.5% reservation i.e. one seat in diploma course VLDD for candidates from Village Riwasa, Mahendragarh is to be reserved, however he has to qualify the entrance test"

The Board of Studies discussed the agenda thoroughly and approved that one seat may be reserved for the aspirants of Village Riwasa Distt. Mahendragarh in VLD diploma course from Academic Session 2017-18. The candidates of village Riwasa will have to apply in VLD diploma course as per the Prospectus against the additional one seat and will have to qualify the diploma entrance test.

A separate merit list of all the qualified candidates under this category will be prepared and the admission will be made on merit irrespective of the category of the candidates. The candidates will be required to submit a proof of residence duly attested by the Sarpanch of Village, Riwasa, Distt. Mahendragarh, at the time of counseling.

Agenda Item No. 4. Inclusion of English Course as non-credit (0+1) in 1st year BVSc&AH programme of this University w.e.f. Academic Session, 2016-17

One English Course as non-credit (0+1) in 1st year BVSc&AH programme of this University w.e.f. Academic Session, 2016-17 was approved in 251st meeting of Board of Studies vide agenda item no. 8 on 18.11.2016. The same was included in 35th meeting of Academic Council on 27-01-2017 vide agenda item no. 35A-5 for approval from Academic Council. The Academic Council approved the agenda as proposed with the resolution that the Dean COVS may formulate the course content, exam procedure, grading etc. and after recommendation of Board of Studies the issue may be placed before Academic Council. The Dean COVS then formulated the course content, exam procedure, grading, and break up of marks for mid-term and final-term examinations, etc.; and the Board of Studies, COVS, approved the same as follows after deliberations.

B.V.Sc & A.H. 1st Year Communicative English (0+1)

Course content:

Section A: Spotting the errors pertaining to noun, pronoun, adjective and adverb, subject-verb concord.

Section B: Grammar – Tense, Voice, Narration, Modals.

Section C: Vocabulary Development through Synonyms, Antonyms, formation of words with affixes.

Section D: Phonetic symbols and Transcriptions.

Section E: Developing Writing Skills: Writing small paragraphs on general and current issues, events and

Letter Writing/Application

Section F: Translation from Hindi to English

Examination: The examination shall be conducted batch wise in the practical class of each group and shall

consist of written component and communicative (speaking) part.

Practical:

- i) Listening Comprehension
- ii) Reading Comprehension
- iii) Group Discussion

Grading: S/US (S- satisfactory, US- Unsatisfactory)

Minimum Marks for S = 40%

Ratio of Marks in Mid term and Final Exams:

Mid Term: Maximum marks - 40

Final: Maximum marks – 60

For both mid-term and final-term examination, 50% will be written component and 50% will be communicative (speaking) component.

Time of Mid-term examination: It shall be conducted alongwith II Internal Assessment.

Time of Final-term examination: It shall be conducted 15 days prior to Final Examination.

Agenda Item No.5. Revision of Merit Scholarship for UG/ Diploma Students:

The proposal of Dean, COVS, LUVAS, Hisar to enhance the rate for the award of merit scholarship to 25% of UG/diploma students was discussed keeping in view that the fee of the students has almost doubled from the time these rates were revised in 2012-13 and the inflation being another factor. After thorough discussion, the revised scholarship and financial liability thereafter for UG degree programs (BVSc&AH, B.Tech) and diplomas (VLDD/DVLT) was approved as under:

It was also decided that the liability will be met out of the State scheme and there will be no effect on the income of fee and fine.

Agenda Item No. 6. Reservation of additional four seats for Animal Husbandry Department of GNCT of Delhi for admission in VLD diploma course in LUVAS, Hisar.

The Director, Animal Husbandry, Govt. of NCT of Delhi had submitted a request to the Worthy Vice-Chancellor for reservation of four additional seats for the in-service candidates of Animal Husbandry Department, Delhi or fresh candidates of NCT Delhi for admission to VLD diploma course in LUVAS, Hisar. The Vice-Chancellor has approved the four additional seats for in-service candidates or fresh candidates of

NCT Delhi as per terms and conditions mentioned below. These terms and conditions have already been communicated to the Director, Animal Husbandry, GNCT, Delhi. His consent regarding acceptance of these terms and conditions has been received.

Terms and conditions

- 1) These will not be paid seats. The Animal Husbandry Department, Delhi/candidate will deposit Rs. 40,000/- per seat per year to the Director, IPVS, Hisar at the time of admission/registration.
- 2) The students will pay fee at par with the state of Haryana as per the Prospectus.
- 3) The admission procedure/eligibility criteria for the in-service candidates of Animal Husbandry Department, Delhi will be same as for the in-service candidates of Animal Husbandry and Dairying Department, Govt. of Haryana.
- 4) The eligibility criteria for fresh candidates of NCT, Delhi will be same as for the Haryana Residents. However, they will also have to send a hard copy of their application to Director IPVS, through Director Animal Husbandry, Delhi.
- 5) All the inservice candidates applying for admission in LUVAS will also have to send a hard copy of their application to the Director, IPVS through the Director, Animal Husbandry, NCT Delhi.
- 6) The employees of Animal Husbandry department, Delhi as well as students of NCT will be eligible for admission, provided they fulfill the eligibility criteria as per the Prospectus.
- 7) The admission will be totally on the basis of merit of Entrance Test conducted by LUVAS. A separate merit list will be prepared for the qualified candidates of NCT, Delhi, including in-service candidates. First preference will be given to the in-service candidates of Animal Husbandry department, Delhi and if the seats remain vacant, the fresh candidates of NCT, Delhi will be admitted on the basis of merit in the entrance test. The vacant seats, if any, will not be transferred to any other category of seats.

The Director, Animal Husbandry, Govt. of NCT of Delhi has also given a certificate that vide publicity will be made every year for the benefits of candidates seeking admission in the VLD diploma course regarding the availability of additional four seats in LUVAS for the employees of Animal Husbandry Department, Delhi and aspirants of NCT Delhi.

The above proposal of The Director, IPVS, LUVAS, Hisar was ratified by the Board of Studies, COVS, LUVAS, Hisar.

^{**}The DBT has approved to reserve two seats for the Haryana residents (out of intake capacity of 13) for admission in Animal Biotechnology. However, the admission of these two candidates will be done on the merit of entrance test plus weightage, if any.

^{***}Upto 3 students will be admitted from entrance test (including weightage) with a maximum intake ceiling of 13 students in MVSc programme in the Department of Animal Biotechnology.
