- 4. Institutional charges, if demanded by the College/Institute, will be paid as per the rates approved by the competent authority.
- 5. The examination material will be provided by the COE.
- 6. The setting of question papers, evaluation and compilation of result will be got done by the COE and result will be declared by the office of Director, IPVS.
- 7. The examination centres will be cancelled by the COE in case of any lapse observed / reported regarding conduct of examination
- 8. Date sheet, sitting plan, duty of staff, requisition of vehicles, etc. will be prepared / assigned / made by the Director, IPVS in consultation with COE.
- 9. Refreshment charges for the staff on duty will be paid on bill basis as per the rates approved by the competent authority.
- 10. The remuneration to the staff on duty will be paid as per the approved rates.
- 11. The funds for all these activities will be provided / arranged by the Director IPVS.
