Agenda Item No. 3. Enhancement of Internship allowance to Internship students of B.V.Sc.&A.H. degree programme.

The Board of Studies, COVS approved the increase in internship allowance of BVSc&AH degree programme from Rs. 12000/- to Rs. 17000/- on the pattern of internees of PGIMS and PGIDS Rohtak.

Agenda Item No. 4. Forwarding of application of Dr. Gaurav Gupta, Assistant Professor for Netaji Subhas-ICAR International Fellowship for the year 2018-19.

After discussing the agenda at a great length, the forwarding of application of Dr. Gaurav Gupta, Assistant Professor, VPT for Netaji Subhas-ICAR International Fellowship for the year 2018-19 was not approved by the Board of Studies, COVS as the Ph.D. degree awarded by the institute (Institute of Cardiovascular Sciences, College of Medical and Dental Sciences, The Medical School, University of Birmingham, UK) is not in relevant discipline. Since as per point 8.1 (ii) of the Career Advancement Scheme implemented in LUVAS, 'An Assistant Professor with completed service of four years, possessing Ph.D. Degree in the relevant discipline shall be eligible, for moving up to AGP of Rs. 7,000'. Therefore, acquiring of a Ph.D. degree in the discipline of Medical Sciences makes him ineligible for future promotions.

Agenda Item No. 5. Addition to the modalities of Communicative English (0+1) Course of 1st year B.V.Sc.&A.H. program.

The following modalities were approved for inclusion in the existing modalities of Communicative English (0+1) Course in relation to re-allotment of course to a student if he/she gets US-grade after appearing in the examination or because of Short of Attendance, adjustment of time table and reflection of English course in the transcript. In addition, the existing time of final examination was also changed as follow.

Re-allotment of Course:

- a) If any student gets US-grade because of Short of Attendance (< 75% attendance), he/ she will register it as Teaching repeat course till attendance requirements are complete and pass the course with S-grade during the course of study of BVSc&AH program.
- b) If any student gets US-grade after completion of attendance requirement ($\geq 75\%$ attendance), he/she will register it as Non-teaching repeat course till it is passed with S-grade at any stage during the course of study of BVSc&AH program.

Adjustment of time table: As repeat teaching course, the time table will be adjusted in consultation with the teacher. Most suitably, it can be during morning or evening zero hours.

Reflection of English course in transcript: The result of Communicative English (0+1) Course will be reflected in the transcript of BVSc&AH program, retrospectively.

Time of Final-term examination: It shall be conducted during Final-term practical examination.
