Agenda Item No. 1. Confirmation of the proceedings of 267th meeting of BOS held on 15.02.2020 at 10.00 AM.

Agenda Item No. 2. Postponement of Internship training programme of BVSc&AH students during the academic year 2019-20 and postgraduate admission for the Academic session 2020-21.

Due to the current pandemic COVID-19, the teaching work was suspended w.e.f. 14.03.2020 vide Registrar's office notification no. Reg/G-1/2020/733 dated 14.03.2020. Thereafter, there has been

a lockdown w.e.f. 24.03.2020 vide Registrar's office order no. Admn./G-1/2020/199 dated 24.03.2020, which was further extended on 14.04.2020 up to 20.04.2020 or till further orders vide office order no. Reg./G-1/2020/37 dated 14.04.2020 and upto 03.05.2020 vide letter no. Reg/G-1/2020/130 dated 20.04.2020. As per the orders, teaching has been suspended and study materials have been provided to the students for the period of suspension of classes.

As per the approved Academic Calendar, Internship programme for 5th year BVSc&AH students (old VCI) which was scheduled from 06.04.2020 could not be started as Hostels have been vacated. Dean COVS received many mails from students to start Internship programme as it is going on in GADVASU, Ludhiana. The Dean, COVS, GADVASU informed to Dean, COVS, LUVAS that the Internship programme at Ludhiana had already commenced from mid January prior to enforcement of Lockdown. In view of these circumstances following decisions were taken.

1. Internship programme shall be started on resumption of normal Academic Activities as notified by Govt./LUVAS, Hisar.
2. Schedule of PG admissions in LUVAS for the Academic Session 2020-21 will be finalized in a way which favours students of LUVAS.


