The 271st meeting of Board of Studies, COVS, LUVAS was convened in the Conference Hall of Dept. of VAHEE on 22.10.2020 at 11.00 AM. The Chairman, BOS welcomed all invitees and HODs present in the meeting. Following decisions were taken in the meeting.

Agenda Item No. 1. Confirmation of proceedings of 270th meeting of BOS held online on 25.09.2020 at 10.00 AM

The proceedings were confirmed

Agenda Item No. 2. Regarding Examination for students of UG/ PG and Diploma programmes.

The above agenda was submitted by the Registrar, LUVAS through Dean COVS for placing the same before Board of Studies, COVS, LUVAS, Hisar for consideration and further recommendations to the Academic Council. The agenda was placed in the 270th meeting of BOS but was deferred.

This agenda was based on the recommendations of the Committee constituted in reference of orders dated 12.06.2020 of Higher Education and Technical Education Department, Haryana and advisory issued by Joint Secretary, Govt. of India, Ministry of Fisheries, Animal Husbandry & Dairying, Department of Animal Husbandry and Dairying, New Delhi dated 17th June, 2020. The house was apprised that the final examinations of PG programs have been conducted by the Dean PGS vide Notification No. PGS/2020/1123 dated 14.09.2020. The classes of Diploma programs have been started w.e.f. 16.10.2020 as per Registrar's office order No. Reg./A-1/2020/2651+E dated 14.10.2020 and the examinations will be conducted after completion of syllabus.

The recommendations regarding UG program were discussed and following decisions were taken with regards to examinations of B.V.Sc.&A.H. program at COVS, LUVAS, Hisar and IIVER, Bahu Akbarpur.

For B.V.Sc. & A.H. (New VCI) students:

1. **For B.V.Sc.&A.H. First, Second and Third Year (New VCI) students:** The third Internal Assessment will be conducted through oral examination by the concerned teacher(s) via suitable online platform. The annual theory examinations will be conducted through assignments and annual practical examination will be conducted through assignments (50% weightage) and oral examination (50% weightage) by the concerned teacher(s) via suitable online platform.

2. **For B.V.Sc. & A.H. Fourth Year (New VCI) students:** It was decided that the practical classes will be held w.e.f. 18.11.2020 to 24.12.2020 and second & third Internal Assessments will be held during this period in normal way. Preparatory holidays will commence from 25.12.2020 to 31.12.2020 before start of Annual examinations w.e.f. 01.01.2021.

For B.V.Sc & A.H. (Old VCI) students

1. **For B.V.Sc.&A.H. Third and Fourth Year (Old VCI) students:** The internal and final theory examinations will be conducted through assignments and internal and final practical examinations through assignments (50% weightage) and oral examinations (50% weightage) by the concerned teacher(s) via suitable online platform.

Regarding commencement of next academic session, 2020-21, Dean COVS was authorized by BOS to decide the dates in consultation with Registrar and Controller of Examinations and submit the same to Academic Council for approval.

For B. Tech. (Dairy Technology):

The conduct of examinations of B. Tech. (Dairy Technology) program has been taken up by Dean CoDST after approval of the following Agenda Item No 3. & 4. by Chairman BOS, COVS subject to ratification by BOS, COVS. These agenda-items were submitted by Dean CoDST.

Agenda Item No. 3. Conduct of 2nd semester examination of B. Tech. (DT) programme and start of academic session 2020-21


