**Agenda Item No. 1. Confirmation of proceedings of 271<sup>st</sup> meeting of BOS held on 22.10.2020 at 11.00 AM.**

**Agenda Item No. 2. Annual Examination for students of Diploma programmes 2019-2020, regarding.**

The following decisions were taken to conduct examinations of VLDD (1<sup>st</sup> year and 2<sup>nd</sup> year students of VLDD section, LUVAS and 11 affiliated private institutes) and DVLTL (1<sup>st</sup> year students) for the Academic Year 2019-2020.

**1. For VLDD 1st and 2nd Year students of IPVS, LUVAS and affiliated Institutes:**

The annual theory examinations will be conducted through viva voce examination (100% weightage) by calling students of constituent college and affiliated colleges to LUVAS campus and will be conducted by the faculty of LUVAS, Hisar.

The annual practical examinations will be conducted by the teachers concerned of LUVAS or affiliated institutes by calling them in respective colleges by viva-voce examination (weightage 50%) and assignment (weightage 50%). Affiliated colleges will submit the result of practical examinations including assignments and other relevant record of examinations within 10 days of date of last examination to the Directorate of IPVS, LUVAS, Hisar.

**2. For DVLTL 1st Year students:** The annual theory and practical examinations will be conducted by the concerned teacher(s) in physical mode. Theory and practical examinations will comprise of assignment component (weightage 50%) and viva-voce examination (weightage 50%).

**Evaluation of professional training of DVLTL:** Final examination of professional training of DVLTL 2nd Year students will be conducted through oral examination (100% weightage) by the concerned teacher(s) by calling students to LUVAS campus.

**Agenda Item No. 3. Change in cut-off date of admission process for Diploma courses, regarding.**

As the admission process for diploma courses has been delayed due to COVID-19 pandemic, therefore, the last date of completion of admission process for the Academic Session 2020-21 was extended to 31st January 2021 or any further notification in this regard.

**Agenda Item No. 4. Revised format for Diploma awarded to Diploma pass out students, regarding.**

The following decisions were taken with regards to format of Diploma certificates to the passing out students of VLD Diploma.

1. The Diploma certificates to be awarded by College of Vety. Sciences, LUVAS, Hisar shall bear the seal of College of Vety. Sciences and signature of Dean, COVS, LUVAS, Hisar.
2. The Diploma certificates to be awarded by Director IPVS to the passing out students of the affiliated institutes/colleges which don't come under Schedule-I as per VCI Act 1984 shall bear seal and signature of Directorate of IPVS, LUVAS, Hisar
3. The Diploma certificates to be awarded by the Dean of the affiliated college which has come under Schedule-I as per VCI Act 1984 shall bear seal and signature of Principal/ Dean of the affiliated college.
4. Pass port size photograph of the student shall be affixed on the certificates of VLDD and DVLTL.

**Agenda Item No. 5. Conductance of Student READY program I & II of the academic session 2019-20 of B. Tech (DT)**

It was decided that the students of B. Tech. (Dairy Technology) degree program who could not complete Students' READY programmes I & II at the end of 2<sup>nd</sup> and 4<sup>th</sup> semester, respectively, due to COVID-19 pandemic, may be allowed to register for next semester (Academic Year 2020-21) and these READY programmes will be completed during course of degree programme as and when the pandemic situation improves.

**Agenda Item No. 6. Inter-change of course program for 7<sup>th</sup> and 8<sup>th</sup> semester of B. Tech (DT) 4<sup>th</sup> year of academic session 2020-21.**

It was decided to inter-change course program of 7<sup>th</sup> semester (in-plant training program DT-411 (0+20) with course program of 8<sup>th</sup> semester for B. Tech (DT) 4<sup>th</sup> year students for the Academic Session 2020-21 only, as the private industries are not allowing the students for in-plant training due to COVID-19 pandemic.


