**Agenda Item No. 2. IIVER Inspection report:27.1.21; Assessment of Facility of IIVER for increasing intake capacity of seats in VLDD**

The Director, IPVS apprised the house in detail about the facilities for VLD Diploma at IIVER, Bahuakbarpur in the light of the inspection report of the Committee constituted for assessment of facilities for increasing seats from 78 to 90 as per government's NOC for VLDD diploma course for the year 2020-21.

The house discussed the issue at length within the framework of existing Norms, procedure and guidelines of LUVAS, Hisar meant for 60 students and feasibility of teaching and conducting practical for 90 students as per existing Norms. The Chairman apprised the house that as per the existing Norms,

the COVS, LUVAS, Hisar is admitting 90 students in VLD Diploma. After a long deliberation on the issue, the house reached to the conclusion that existing Norms, procedure and guidelines are sufficient for admitting 60 to 90 students provided the Lecture Hall has sufficient space for accommodating the students. It was also recommended that the number of practical batches should be three if the students are more than 60 in a class.

In view of above, the house decided that the intake capacity in VLD Diploma at IIVER, Bahuakbarpur may be increased from 78 to 90 students. The house also recommended that the Norms, procedure and guidelines should be reframed, if there is need to increase the intake capacity beyond 90 students.

**Agenda Item No. 3 Filling of enhanced seats in VLD Diploma at IIVER, Bahuakbarpur**

The Board of Studies approved the filling of enhanced seats (12 in no.), as per Agenda Item No. 2., in VLD Diploma at IIVER, Bahuakbarpur from Academic Session 2020-21 as per reservation policy of Haryana Govt.


