Item No. Registration of Internship Training programme in respect of BVSc&AH students of academic year 2022-23 (Batch 2018).

As per Veterinary Council of India Regulations 2016, successful completion of Internship Training is an essential requirement for the award of Degree of BVSc & AH programme. As per approved academic calendar of the University, the registration of Internship Training Programme of this College was scheduled on 28.3.2023 but the registration was not made upto 28.03.2023. Before registration the students have to register with the Haryana Veterinary Council through online system, as the result of BVSc&AH students 4th year (Batch 2018) was declared on 31.03.2023, the registration for Internship Training Programme of this College to be held on 07.04.2023 instead of 28.03.2023.

Recommendations of the committee:

- 1. Keeping in view the requests made by the students, those who were unsuccessful in the supplementary examination be given one more chance of appearing in supplementary examinations for the subjects in which they were unsuccessful. The provision of awarding grace marks in result shall not apply for these examinations. The candidate willing to appear in these examinations will be required to pay the supplementary examination fee as per rules.
- 2. The committee is of the view that the residential requirement of the diploma courses may be revised and hence the rule 12 of Rules and Regulations Governing Diploma Courses may be amended as under:

The proposed amendment in the rule no. 12 shall be applicable to 1st and 2nd year students of IPVS, LUVAS and Affiliated Private Colleges enrolled for the session 2021-22 and thereafter.
