Subject: Revision of pension/family pension of pre 2016 **retired Medical Officers** of Haryana Government; (7<sup>th</sup> CPC) w.e.f. 01.01.2016 -- Regarding Non Practicing Allowance (NPA).

Sir/Madam,

I am directed to invite your attention to the Finance Department's Office Memorandum No. 2/23/2016-1Pension dated 10.01.2018 vide which it has been decided by the State Government to revise the pension/family pension in respect of all Haryana Government pensioners/family pensioners, who retired/died **prior to 01.01.2016**, with effect from 1<sup>st</sup> January, 2016 followed by clarification memo of even number dated 30.01.2018/01.02.2018, 11/22.10.2018, 07.12.2018 and 31.01.2019.

In the case of Medical officers, the emoluments reckoned for calculation of pension include Non Practicing Allowance (NPA). The pay of the medical officers is revised in accordance with the specific provisions made in the Revised Pay Rules. The manner in which the pay of the Medical Officers is to be revised w.e.f. 01.01.2016 is prescribed in **Rule 7(1)B** of the HCS (Revised Pay) Rules 2016.


Accordingly, it has now been decided that for the purpose of revision of pension of pre-2016 retired medical officers in accordance with this department's OM No. 2/23/2016-1Pension dated 10.01.2018, their pay will be notionally revised/refixed w.e.f. 01.01.2016 based on the formula for revision of pay as applicable to the medical officers in the 7<sup>th</sup> CPC as well as in the intervening Pay Commissions. NPA on pre-revised pay at the rate as applicable as on 01.01.2016 shall be added to such notional pay as on 01.01.2016 to arrive at pension/family pension of retired medical officers w.e.f. 01.01.2016.

Further, NPA to serving medical officers has been revised @20% of basic pay w.e.f. 01.05.2018 by the Pay Revision Branch. Accordingly, the pension/family pension of retired medical officers shall also be revised w.e.f. 01.05.2018 by adding NPA @20%, to the notional pay as on 01.01.2016 instead of the NPA admissible as on 01.01.2016.




The revision of pension/family pension of retired medical officers in the above manner will be further subject to the condition that the notional pay as on 01.01.2016 plus NPA does not exceed the basic pay of Rs. 224100/-.


