
### **"Corrigendum"**

It is for the information of the candidates who want to seek admission in VLDD & DVLTL diploma programmes, that the following amendments have been made in the Diploma prospectus 2023-24 with the approval of the competent authority:

- i. In compliance of instructions received from Government of Haryana vide Endst. No. 3615(CFMS)-AH-4-2023/4373 dated 24.07.2023 regarding fixation of fee structure for the admission of VLDD course in private college in the Haryana State for the batch 2023-24, the competent authority has fixed the fee structure of VLDD course mentioned in the Chapter-V (Diploma Prospectus 2023-24) for the private VLDD colleges affiliated to LUVAS for the session 2023-24. The details of fee structure of Private Affiliated colleges/institutes for VLDD course for the session 2023-24 are enclosed herewith in Annexure-1. The fee structure includes tuition fee and all other charges.
- ii. The upper age limit for diploma programmes has been increased from 22 to 25 years for General category and 27 to 30 years for SC/DSC/BC category.
- iii. Last date of submission of online application form for the VLDD & DVLTL diploma programmes, is hereby extended as per details given below:

It has also been decided that after the last date of submission of online application form, a correction window for the candidates who have submitted online application form for VLDD & DVLTL for the academic year 2023-24 will be opened from 08.08.2023 to 10.08.2023 to edit/modify their particulars in the Online Application Form (**except category**). Candidates can edit/modify their particulars by using their user id and password on the admission portal.
- v. The Entrance test 2023 for VLDD programme (VLDD-ET 2023) which was scheduled to be held on 10.09.2023 has been rescheduled and will be held on 24.09.2023.
