Subject: Revision of Pension w.e.f 01.01.2016 of Pre-2016 Retired teachers as per 7th CPC.

As per instructions issued by this office vide letter No. LUVAS/CVU/B-1/2018/5388-5450 dated 03.12.2018, pay scales of teachers of this University have been revised w.e.f. 01.01.2016 as per 7th CPC. In this regard, it is stated that as per instructions issued by the Finance Department, Govt. of Haryana vide letter No. 2/23/2016-1 Pension dated 10.01.2018, pension/family pension of retired/deceased employees has to be revised by fixing their pay notionally as per 7th CPC in the Pay Matrix Level corresponding to the pay in pay scale/pay band and grade pay at which they retired/died.

A few cases for revision of pension of retired teachers (Pre-2016) w.e.f. 01.01.2016, as received from the Depts, were earlier sent to the Joint Director (Local Audit) for verification. But the same were not admitted in audit.

Now, the Joint Director (Local Audit) has admitted one case of retired teacher (Pre-2016) for revision of pension w.e.f 01.01.2016 by fixing his pay notionally as on 01.01.2016 in accordance with Pay Matrix Academic Level of 7th CPC.

In view of the above, you are requested to process all such cases of retired/deceased teachers (Pre-2016) of your Department/Office for revision of their pension/family pension w.e.f. 01.01.2016 on the proforma prescribed and send necessary proposal to this office for further action in the matter please.
