Sir/Madam

I am directed to refer to State Government letter No. 8453-3GSII-72/37452, dated 22.12.1972, No. 5197-3GSII-74, dated 24-10-1974, No. 769-3GSII-76/5165, dated 15-03-1976, No. 16/93/2008-6GSII, dated 16.07.2015 and dated 27-06-2016 on the subject noted above and to say that the matter has been reconsidered by the Government and it has been decided that the Children Education Allowance is increased from the existing rates of Rs. 750/- per month to Rs. 1125/- per month per child with immediate effect on the basis of the recommendations of the 7<sup>th</sup> Central Pay Commission for the dependents of deceased Govt. Employee who die while in service. This is subject to entitlement of two living children. Other terms and conditions will remain unchanged.

2. It is also clarified that the reimbursement of fee would be made by the department concerned.

3. This issues with the concurrence of Finance Department conveyed by their U.O. No. 13/02/2019-5FR/18099 dated 29-07-2019.
