Sub:- Change of option from CPF to Pension Scheme for the employees of LUVAS, Hisar.

In pursuance of the approval accorded by the State Government, the Vice-Chancellor, LUVAS, Hisar is pleased to grant the last and final chance for change of option from CPF to Pension Scheme within four months from the date of issue this letter i.e. upto 31.01.2020 for the left over employees of this University subject to the following conditions:

I In case of the serving employees who opt for pension, employer's contribution along with the interest to be transferred to the pension fund.

II For retired employees/families of deceased employees, a certain multiple of employer's contribution to Provident Fund and interest thereon, received by the employee on retirement to be refunded.

III Pension/Family Pension to those who now opt to join the pension scheme, will be payable with effect from the date of notification of the scheme, issued by the Administrative Department. However, the employees retiring after that date will be eligible for pension with reference to their respective date of retirement.

2. However, the matter has been referred to the State Government for seeking clarification on certain points in this regard and on receipt of reply from the Government, further action in the matter will be taken by this office accordingly.

3. In the meantime, all the employees(including retired employees/families of deceased employees) of your Deptt./Office, who opted for CPF Scheme earlier and now want to change their option to Pension Scheme, should apply for the same within stipulated period i.e. upto 31.01.2020 through their Head of Deptt./Office on the relevant proforma. Specimen copy of Form of option (three Nos.) meant for existing employees, retired employees and family member of deceased employees are enclosed for the purpose.

4. Options received from the employees/retirees/dependant of deceased employees shall be got diarised and pasted in Service Book of the concerned employees after having been accepted by the competent authority and entry in this regard may be made in the Service Book facing the entry already made for option for CPF Scheme. An attested copy of the option may be sent to this office along with Service Book and application for allotment of GPF

Account No _____ along with nomination form(whenever required) within one week i.e. upto 07.02.2020 (after the expiry of period of four months for change of option) with a certificate that all options so received by due date have been sent to the Comptroller's Office after taking necessary action, as stated above.

5. All the concerned employees/retirees/family of deceased employees may be informed accordingly to exercise their option in the prescribed proforma within stipulated period. Simultaneously, the employees who were in service after the establishment of this University but have since died after retirement (i.e. after 01.12.2010), the concerned widow/widower or the eligible member for family pension be informed by registered post.

6. It may be made clear to the concerned employees/retirees etc. that this is the last and final chance as per approval of the State Government and no request for change of option shall be entertained after due date.

7. It is also requested that it may be ensured that the information regarding change of option from CPF to Pension Scheme be got noted from all the concerned employees of the Departments who are presently being governed by CPF Scheme. It may also be ensured that a copy of these instructions may be sent to those employees, who were in service after the inception of this University i.e. on or after 01.12.2010 and have since been retired from service but were governed by CPF Scheme. In case at a subsequent stage, it is noticed that these instructions have not been got noted from the concerned employees/retirees/dependent of deceased employees or a copy thereof has not sent to the concerned retired employees etc. who retired after the inception of this University, responsibility thereof will lie on the concerned Head of Deptt./Office and concerned dealing hand as well.
